Imphal, the 3rd November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/18: Whereas, Town Planning Department, Manipur in collaboration with the Siphong Sekmai Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Siphong Sekmai Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Siphong Sekmai Municipal Council in its meeting held on 24.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Siphong SekmaiMunicipal Council area including ward boundary.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED SHIKHONG SEKMAI MUNICIPAL AREA

Starting from the southwest corner of C.S. Dag No. 1138 (Ward No. 2) of Sekmai Kumbi Village No. 116, Sheet No. 2, adjacent to the road, the boundary line goes towards northeast covering western boundaries of C.S. Dag No. 1137, 1138, 1134, 1141, 1142, 1111, 1109, 1101, 1100, 1099, 1097, 1412, 1096, 1095, 1093 and goes east covering C.S. Dag No. 1091, 1162, 1168, 1169, 1170, 1171, 1172, 1173, 1213, 1227, 1229, 1230, 1246, 1247, 1249, 1250, 1251, 1292, 1297, 1256.

The line continues towards Sekmai Kumbi Village No. 116, Sheet No. 1, covering C.S. Dag No. 455, 454, 503, 460, 462, 463, 466.

Then continues towards Sekmai Kumbi Village No. 116, Sheet No. 2, covering C.S. Dag No. 1326, 1329, 1328.

The line again moves north towards Sekmai Kumbi Village No. 116, Sheet No. 1, covering western boundaries of C.S. Dag No. 496, 495, 494, 481, 405, 40, 408, 423, 418, 4151, 394, 382, 383, 384, 385 and goes south covering C.S. Dag No. 391, 417, 421, 424, 425, 426, 430, 484, 489, 505, 496.

Then continues south towards Sekmai Kumbi Village No. 116, Sheet No. 2, covering C.S. Dag No. 1328, 1329, 1335.

Further, the line continues east towards Sikhong Village No. 117, Sheet No. 1, covering C.S. Dag No. 156, 168, 185, 186, 196, 197, 195, 194, 193, 192, 191, 131, 130, 125, 224, 225, 227, 228, 254 and goes south covering C.S. Dag No. 222, 221, 220, 271, 270, 272 then goes east covering C.S. Dag No., 269, 268, 267, 266, 265, 264, 263, 262, 370, 372, 418, 417, 364, 425, 420.

The line moves south towards Sikhong Village No. 117 Sheet No. 2, along the road covering eastern boundaries of C.S. Dag Nos. 1200, 1197, 1182, 1195, 1192, 1171, 1172, 1189, 1174 and goes towards north along the river covering C.S. Dag No. 1153, then moves south covering C.S. Dag Nos. 1137, 1147, 1146, 1144, 1143, 1149, 1150, 1008, 1013, 1015, 1016, 1017, 1019, 1020, 1021, 1024, 1028, 1032, 1036, 1038, 1037, 1043, 1044, 1045, 1047, 1046.

The line then moves towards Ukhongsang Village No. 118, Sheet No. 1, covering C.S. Dag No. 821, 825, 829, 754, 911, 928, 903, 902, 901, 900 and turn towards west covering C.S. Dag Nos. 897, 898, 895, 890, 889, 883, 872, 871, 869, 868, 706, 562, 561, 560, 545, 544.

The line goes south towards Sheet No. 2 of Ukhongsang Village No. 118, covering the eastern boundaries of C.S. Dag No. 1172 and the line moves west towards Sheet No. 1 of Ukhongsang Village No. 118, covering the southern boundaries of C.S. Dag Nos. 298, 299, 302, 303, 305, 306, 309, 283, 284, 285, 138, 140, 264, 149, 152, 153, 155, 156, 160, 166, 167, 168, 34, 36, 12 and turns towards east covering the northern boundaries of C.S. Dag Nos. 12, 13, 17, 18. The line continues towards south covering the eastern boundaries of C.S. Dag Nos. 18, 23, 25, 26, 27, 34, 170, 171, 232 and goes north covering the western boundaries of C.S. Dag Nos. 330, 325, 352, 349, 365, 366, 371. Then the line goes south covering the eastern boundaries of C.S. Dag Nos. 371, 366, 365, 349, 352, 325 and turns towards east covering the northern boundaries

of C.S. Dag Nos. 485, 627, 805, 806, then continues towards north covering the western boundaries of C.S. Dag Nos. 794, 800, 793, 787, 785, 780, 776, 771, 769 and turns east covering the northern boundaries of C.S. Dag Nos. 769, 770 then goes north along the road. The line turns towards west covering the southern boundaries of C.S. Dag Nos. 763, 762, 761, 760, 758, 675, 676, 402, 403 and turn towards north covering western boundaries of C.S. Dag Nos. 403, 399, 397, 390. The line moves west along the road until it meets the northeast corner of C.S. Dag No. 382 and goes west along the road until it reaches northeast corner of C.S. Dag No. 201. The line goes west covering southern boundaries of C.S. Dag Nos. 201, 195, 191 and turn towards north.

The line continues west towards Sekmai Kumbi Village No. 116, Sheet No. 2, along the road covering the southern boundaries of C.S. Dag Nos. 1155, 1154, 1153, 1147, 1145, 1140, 1139, 1138 and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED SHIKHONG SEKMAI MUNICIPAL AREA

WARD NO. 1

Starting from the northeast corner of C.S. Dag No. 1410 of Sekmai Kumbi Village No. 116, Sheet No. 2, the ward Boundary line goes towards north.

The line continues north towards Sikhong Village No. 117, Sheet No. 1, covering the western boundaries of C.S. Dag Nos. 296, 288 and goes east covering the northern boundaries of C.S. Dag Nos. 288, 291, 319, 320, 323, 328, 345.

The line then moves east towards Ukhongsang Village No. 118, covering the northern boundaries of C.S. Dag Nos. 587, 588.

The line continues east towards Sikhong Village No. 117, Sheet No. 1, covering the western boundaries of C.S. Dag Nos. 350, 352, 353 and goes northeast covering the western boundaries of C.S. Dag Nos. 378, 374, 370, 372 and goes south covering the eastern boundaries of C.S. Dag Nos. 372, 370, 410. The line continues west covering the southern boundaries of C.S. Dag Nos. 407, 376 and goes south covering eastern boundaries of C.S. Dag Nos. 394, 393, 392, 477, 479, 390, 389, 387.

The line continues south towards Ukhongsang Village No. 118, covering eastern boundary of

C.S. Dag No. 763 and turns towards west covering southern boundaries of C.S. Dag Nos. 763, 762, 761, 760, 758, 675, 676, 402, 403 and turn towards north covering western boundaries of C.S. Dag Nos. 403, 399, 397, 390 and the line crosses the road, meeting the starting point.

WARD NO. 2

Starting from the southwest corner of C.S. Dag No. 1138 of Sekmai Kumbi Village No. 116, Sheet No. 2, adjacent to the road, the boundary line goes towards northeast covering western

boundaries of C.S. Dag Nos. 1137, 1138, 1134, 1141, 1142, 1111, 1109, 1101, 1100, 1099, 1097, 1412, 1096, 1095, 1093 and goes east covering C.S. Dag No. 1091, 1162, 1168, 1169, 1170, 1171, 1172, 1173, 1213, 1227, 1229, 1230, 1246, 1247 and turn east covering the northern boundaries of C.S. Dag Nos. 1247, 1243, 1241, 1240, 1376, 1384, 1386, 1397, 1401, 1402. The line goes south along the road until it meets the southeast corner of C.S. Dag No. 1395 and goes towards west covering the southern boundaries of C.S. Dag Nos. 1393.

The line moves towards Ukhongsang Village No. 118, covering C.S. Dag No. 382 and goes west along the road until it reaches northeast corner of C.S. Dag No. 201. The line goes west covering southern boundaries of C.S. Dag Nos. 201, 195, 191 and turn towards north.

The line continues west towards Sekmai Kumbi Village No. 116, Sheet No. 2, along the road covering the southern boundaries of C.S. Dag Nos. 1155, 1154, 1153, 1147, 1145, 1140, 1139, 1138, meets the starting point.

WARD NO. 3

Starting from the northwest corner of C.S. Dag No. 1360 of Sekmai Kumbi Village No. 116, Sheet No. 2, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag Nos. 1360, 1361, 1362, 1373 and continues towards west along the road covering the southern boundaries of C.S. Dag Nos. 1373, 1374, 1371, 1370, 1365, 1303, 1302, 1249, 1250, 1251 then the line continues north covering the western boundaries of C.S. Dag Nos. 1251, 1292. The line turns towards east covering the northern boundaries of C.S. Dag Nos. 1292, 1291, 1290, 1288, 1286, 1310, 1311, 1315, 1350, 1348, 1346, 1345, 1343, meets the starting point.

WARD NO. 4

Starting from the southeast corner of C.S. Dag No. 1329 of Sekmai Kumbi Village No. 116, Sheet No. 2, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag No. 1335 and turns towards west along the road covering the southern boundaries of C.S. Dag Nos. 1331, 1339, 1340, 1318, 1317, 1281, 1282, 1283, 1284, 1265, 1264, 1260, 1259, 1256, 1255.

The line then continues north towards Sheet No. 1 of Sekmai Kumbi Village No. 116, covering the western boundaries of C.S. Dag Nos. 455, 454 and turn east covering the northern boundaries of C.S. Dag Nos. 503, 460, 462, 463, 466.

The line continues towards Sheet No. 2 of Sekmai Kumbi Village No. 116, covering the western boundaries of C.S. Dag Nos. 1326, 1329, 1328.

The line again moves north towards Sheet No. 1 of Sekmai Kumbi Village No. 116, covering the western boundaries of C.S. Dag No. 496, 495, 494, 481, 405, 40, 408, 423, 418, 4151, 394, 382, 383, 384, 385 and goes south covering C.S. Dag No. 391, 417, 421, 424, 425, 426, 430, 484, 489, 505, 496.

Then the continues south towards Sheet No. 2 of Sekmai Kumbi Village No. 116, covering the eastern boundaries of C.S. Dag No. 1328 and meets the starting point.

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 156 of Sikhong, Village No. 117, Sheet No. 1, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 156, 168, 185, 186, 196, 197, 195, 194, 193, 192, 191, 131, 130, 125, 224, 225, 227, 228, 254 and goes south covering the eastern boundaries of C.S. Dag Nos. 222, 221, 220, 271, 270, 272 then continues towards east covering the northern boundaries of C.S. Dag Nos. 269, 268, 267, 266, 265, 264, 263, 262. The line continues west covering the southern boundaries of C.S. Dag Nos. 370, 314, 354, 233, 284, 164 and turns towards north covering the western boundaries of C.S. Dag Nos. 163, 161 and meets the starting point.

WARD NO. 6

Starting from the northeast corner of C.S. Dag No. 1200 of Sikhong, Village No. 117, Sheet No. 2, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag Nos. 1200, 1182, 1195, 1192, 1171, 1172, 1189, 1174 and goes towards north along the river covering the western boundaries of C.S. Dag No. 1153 then moves towards south covering the eastern boundaries of C.S. Dag Nos. 1137, 1147, 1146, 1144, 1143, 1149, 1150, 1008, 1013, 1015, 1016, 1017, 1019, 1020, 1021, 1024, 1028, 1032, 1036, 1038. The line goes towards west covering the southern boundaries of C.S. Dag No. 1040 and turns towards north covering the western boundaries of same Dag No.

The line moves west towards Ukhongsang Village No. 118, covering the southern boundaries of C.S. Dag Nos. 802, 803, 794 and turns towards north covering the western boundaries of C.S. Dag Nos. 794, 800, 793, 787, 785, 780, 776, 771, 769 and turns east covering the northern boundaries of C.S. Dag Nos. 769, 770. The line crosses the road.

The line then continues north towards Sikhong Village No. 117, Sheet No. 2, along the road covering the western boundaries of C.S. Dag Nos. 1011, 1007, 1002, 1003.

Further, the line moves towards Sheet No. 1 of Sikhong Village No. 117, covering the western boundaries of C.S. Dag Nos. 399, 398, 397, 395 and turns towards east covering the northern boundaries of C.S. Dag Nos. 395, 341 and the line crosses the road covering the C.S. Dag No. 406. The line continues north along the river until it reaches the southwest corner of C.S. Dag No. 361 and continues east covering the northern boundaries of C.S. Dag Nos. 361, 423, 425 then the line continues towards south and meets the starting point.

WARD NO. 7

Starting from the northeast corner of C.S. Dag No. 1037 of Sikhong Village No. 117, Sheet No. 2, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 1037, 1043, 1045, 1047, 1046.

The line moves towards Ukhongsang Village No. 118, Sheet No. 1, covering the eastern boundaries of C.S. Dag Nos. 821, 825, 829, 754, 911, 928, 903, 902, 901, 900 and turn towards west covering C.S. Dag Nos. 897, 898, 895, 890, 889, 883, 872, 871, 869, 868, 706 and turns

towards north along the road covering the western boundaries of C.S. Dag Nos. 706, 867, 866, 864, 862, 861, 859, 848, 608, 609, 610, 611, part of 408. The line goes east along the road and until it reaches the southeast corner of C.S. Dag No. 627 and goes towards north covering the western boundaries of C.S. Dag No. 805. The line continues east covering the northern boundaries of C.S. Dag Nos. 805, 806, 795, 805.

The line moves towards Sikhong Village No. 117, Sheet No. 2, covering the northern boundaries of C.S. Dag No. 1043 and meets the starting point.

WARD NO. 8

Starting from the northwest corner of C.S. Dag No. 485 of Ukhongsang Village No. 118, Sheet No. 1, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 485, 627 and goes south of same Dag No. Then the line goes west along the road and turn towards south covering the C.S. Dag Nos. 603, 604, 591, 587, 586, 571, 569, 567, 566, 564, 563, 562, 561 and goes towards west covering the southern boundaries of C.S. Dag Nos. 561, 560, 545, 544.

The line goes south towards Sheet No. 2 of Ukhongsang Village No. 118, covering the eastern boundaries of C.S. Dag No. 1172 and goes west and then north of same Dag No.

The line then moves west towards Sheet No. 1 of Ukhongsang Village No. 118, covering the southern boundaries of C.S. Dag Nos. 366, 365, 368, 369, 297 and turns towards north along the road covering the western boundaries of C.S. Dag Nos. 297, 296, 295, 294, 293, 292, 291, 514, 515, 516, 517, 518, 519, 520, the line crosses the road until it meets the southeast corner of C.S. Dag No. 501 and turns towards north covering the western boundaries of C.S. Dag Nos. 577, 408, 485, meets the starting point.

WARD NO. 9

Starting from the northwest corner of C.S. Dag No. 12 of Ukhongsang Village No. 118, Sheet No. 1, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 12, 13, 17 and turns towards south covering the eastern boundaries of C.S. Dag Nos. 18, 23, 25, 26, 27, 34, 170, 171, 232 and goes north covering the western boundaries of C.S. Dag Nos. 330, 325, 352, 349, 365, 366, 371. The line turns east and south along the road covering the eastern boundaries of C.S. Dag Nos. 371, 366, 365, 349, 352, 325, the line crosses the road until it reaches the northeast corner of C.S. Dag No. 945 and goes towards south covering the eastern boundaries of C.S. Dag Nos. 945, 501, 508, 314, 313, 311, 302, 301, 300, 299, 302, 303, 305, 306, 309, 283, 284, 285, 138, 140, 264, 149, 152, 153, 155, 156, 160, 166, 167, 168, 34, 36, 12, meets the starting point.
