No.SCS-401/6/2025-MAHUD-MAHUD/12: Whereas, Town Planning Department, Manipur in collaboration with the Moirang Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Moirang Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Moirang Municipal Council in its meeting held on 18.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Moirang Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Bishnupur in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED MOIRANG MUNICIPAL AREA

Starting from the southeastern corner of C.S. Dag No. 163 (Ward No. 5) of Village No. 52, of Moirang 1st Part (Sheet No. 1), the boundary line goes towards south along the road under C.S. Dag No. 199.

The line continues towards Moirang 2nd Village No. 53 (Sheet No. 2) covering the eastern boundary of C.S. Dag No. 503 (Pt).

The line then moves South towards Sheet No.4 of Moirang 2nd Village No. 53, covering the Eastern boundaries of C.S. Dag Nos. 1506 (Pt) and 1507 (Pt).

The line continues South towards Sheet No.8 of Moirang 2nd Part Village No. 53, covering the Eastern boundaries of C.S. Dag Nos. 3501(Pt), 3546, 3545, 3544, 3507, 3510, 3511 and 3517. The line then moves West covering the Southern boundaries of C.S. Dag Nos. 3517, 3576 and 3525.

The line continues West towards Sheet No.7 of Moirang 2nd, Village No. 53, covering the southern boundary of C.S. Dag Nos. 3052.

The line again continues towards Sheet No. 8 of Moirang 2nd, Village No. 53, covering the eastern boundary of C.S. Dag Nos. 3527.

The line then continues South towards (Sheet No.13) of Moirang 2nd Village No. 53, along the eastern Boundaries of C.S. Dag Nos. 6030, 6027 and 6028, then the line turns east covering the northern boundary of C.S. Dag Nos. 6064, then turns towards north covering the western and northern boundaries of C.S. Dag Nos. 6170 and continues east covering the northern boundaries of C.S. Dag Nos. 6051, 6052 and 6053, then moves south covering the eastern boundary of C.S. Dag Nos. 6053. The line moves east covering the northern boundaries of C.S. Dag Nos. 6061, 6060 and continues north covering the western boundaries of C.S. Dag Nos. 6059, 6058, 6057, 6056, 6045, 6044 and 6043 then the line turns east covering the northern boundaries of C.S. Dag Nos. 6043. The line continues south covering the eastern boundaries of C.S. Dag Nos. 6043, 6044 and 6045 and turns towards east covering the northern and eastern boundary of C.S. Dag Nos. 6085, then the line continues south covering the eastern and southern boundary of C.S. Dag Nos. 6082. The line continues South covering the Eastern boundary of C.S. Dag Nos. 6058 and 6059 and turns towards east covering the Northern and Eastern boundaries of C.S. Dag Nos. 6079, then the line moves towards west covering the southern boundaries of C.S. Dag Nos. 6078, 6074, 6073 and 6071. The line continues south covering the eastern boundary of C.S. Dag Nos. 6123 and continues east covering the Northern boundaries of C.S. Dag Nos. 6128, 6143, 154, 155. Then the line continues south covering the eastern boundary of C.S. Dag Nos. 6156 and continues north covering the western boundary of C.S. Dag Nos. 6151. Then the line moves west along the under C.S. Dag Nos. 6140.

Then the line continues west towards Moirang 2nd Village No. 53 (Sheet No.14), covering the southern boundaries of C.S. Dag Nos. 6412, 6515, 6509 and 6508 and continues south covering the eastern boundaries of C.S. Dag Nos. 6502, 6518, 6519, 6521, 6522, 6523 and crosses the road.

Then the line continues East towards (Sheet No. 15) of Moirang 2nd Village No. 53, covering the southern boundary of C.S. Dag Nos. 7028 and turns towards north covering the western boundaries of C.S. Dag Nos. 7028, 7027, 7026, 7024, 7022, 7021 and 7018. The line then continues along the Moirang-Kumbi road till it touches the South-eastern corner of C.S. Dag Nos. 7007 and continues towards West covering the Southern boundary of C.S. Dag Nos. 7007, then the line continues north covering the western boundaries of C.S. Dag Nos. 7007, 7002 and 7003,

Then the line continues East towards (Sheet No.13) of Moirang 2nd Village No. 53, covering the northern boundary of C.S. Dag Nos. 6018 and turns towards north along the Moirang-Kumbi Road till it touches the southeast corner of C.S. Dag Nos. 6007 then turns west and north covering the western boundaries of C.S. Dag Nos. 6005, 6002.

The line then continues north towards (Sheet No.7) of Moirang 2nd Village No.53, covering the western boundary of C.S. Dag Nos. 3086.

Further, the line moves West towards Moirang 1st Village No. 52 (Sheet No.10), covering the southern boundaries of C.S. Dag Nos. 2287, 2293, 2320, 2295, 2297, 2238, 2237 and 2234 and continues south covering the eastern boundaries of C.S. Dag Nos. 2229 then the line moves west covering the southern boundaries of C.S. Dag Nos. 2231 and 2223.

The line then continues West towards Moirang 1st Village No. 52 (Sheet No. 11), covering the southern and western Boundaries of C.S. Dag No. 2657 and continues towards north covering the western boundary of C.S. Dag Nos. 2653, 2647.

The line continues north towards (Sheet No. 10) of Moirang 1st Village No. 52, covering the western boundaries of C.S. Dag Nos. 2209, 2208 and 2207 and turns east covering the northern boundaries of C.S. Dag Nos. 2204 including 2207, 2211, 2315, 2212, 2213, 2214 and 2215.

Then the line continues north towards (Sheet No. 9) of Moirang 1st Village No. 52, covering the western boundaries of C.S. Dag Nos. 1945 till it touches the southwest corner of C.S. Dag No. 1944 and turn towards north covering the western boundaries of C.S. Dag Nos. 1973, 1974, 1976, 1977 and 1979 then turns west covering the southern boundaries of C.S. Dag Nos. 1980, 1936, 1938 and turns towards north covering the western boundaries of C.S. Dag Nos. 1938, 1937, 1934 and 1931.

Further the line moves west towards (Sheet No.6) of Moirang 1st Village No.52, along the road covering the southern boundaries of C.S. Dag Nos. 1433, 1403, 1402 and 1608 and turns north covering the western boundaries of C.S. Dag Nos. 1608, 1401 and 1338 then turns west covering the southern boundaries of C.S. Dag No. 1340 and turns towards south covering the eastern boundaries of C.S. Dag Nos. 1333, 1336, 1901 and the line turns west covering the Southern boundary of C.S. Dag Nos. 1901.

Then the line continues West towards (Sheet No. 11) of Moirang 1st Village No. 52, covering the southern boundary of C.S. Dag No. 2611 and turns north covering the western boundaries of C.S. Dag Nos. 2611 and 2620. The line then turns west covering the southern boundaries of C.S. Dag Nos. 2610, 2606 and 2598. Then the line continues south covering the eastern boundaries of C.S. Dag Nos. 2596, 2560 and continues west covering the southern boundaries of C.S. Dag Nos. 2638 and 2564 till it reaches the northeastern corner of C.S. Dag

Nos. 2565 then the line continues south and then west covering the eastern and southern boundaries of C.S. Dag Nos. 2565 and 2539.

The line then continues south towards Ngangkhalawai Village No. 51 (Sheet No. 4), covering the eastern boundaries of C.S. Dag Nos. 3043, 3060, 3030 and turns towards west covering the southern boundaries of C.S. Dag Nos. 3089, 3090, 3248 and crosses the road.

Further the line continues west towards (Sheet No. 3) of Ngankhalawai Village No. 51, crossing the N.H. 02 and covering the southern boundaries of C.S. Dag Nos. 2533, 2534 and continues towards north covering the western boundaries of C.S. Dag Nos. 2534, 2524, 2522 then continues till the line reaches the southwestern corner of C.S. Dag Nos. 2501 and continues North covering the Western boundaries of C.S. Dag Nos. 2501, 2492, 2490, 2487, 2486, 2436, 2582, 2435, 2404. Then the line turns east covering the northern boundaries of C.S. Dag Nos.2404, 2439, 2442, 2443 and continues north covering the Western boundaries of C.S. Dag Nos. 2425, 2426 and 2427. Then the line continues west covering the southern boundaries of C.S. Dag Nos. 2412, 2409, 2354 and 2353 and turns towards north covering the western boundaries of C.S. Dag Nos.2353, 2267, 2260 then turns south covering the eastern boundaries of C.S. Dag No. 2260. the line continues east covering the northern boundaries of C.S. Dag Nos. 2358, 2354 and continues north covering the western boundaries of C.S. Dag Nos. 2362, 2364, 2585, 2251, 2253, 2246, then the line continues East covering the northern boundary of C.S. Dag No. 2246 and slightly goes south till it touches the southeast corner of C.S. Dag No. 2243.

Then the line continues east towards Moirang 1st Village No. 52 (Sheet No.3) covering the western boundaries of C.S. Dag No. 601.

the line continues northwest towards (Sheet No.1) of Moirang 1st Village No. 52, covering the Southwestern of C.S. Dag No. 67 and continues east covering the Northern boundaries of C.S. Dag Nos. 67,68, 81, 82, 95 and 140.

Then the line continues north towards (Sheet No.5) of Moirang 1st Village No. 52, covering the western boundary of C.S. Dag No. 903.

the line moves north towards (Sheet No.1) of Moirang 1st Village No. 52, covering the western boundary of C.S. Dag Nos. 148 and turns towards east covering the northern boundaries of C.S. Dag Nos. 148, 153 (Pt), 155 (Pt), 212, 155 (Pt), 164, 163 and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED MOIRANG MUNICIPAL AREA

WARD NO. 1

Starting from the north west corner of C.S. Dag No. of 2601 of Moirang 1st part 11, Village No. 52, the ward boundary line continues towards south covering the eastern boundaries of C.S. Dag No. 2555, parts of 2600, 2597, 2638, 2564 and turns towards west covering the southern boundaries of C.S. Dag No. 2565, 2539. The line then goes towards north along the road.

The line continues towards Ngangkhalawai Sheet No. 4, Village No. 51, the line goes north along the road until it meets the northeast corner of C.S. Dag No. 3010 and turn west covering the northern boundary of C.S. Dag No. 3010 then meets the road. The line then turns towards north along the road until it meets the northwest corner of C.S. Dag No. 3030.

The line moves towards Moirang 1st part 3, Village No. 52, the line goes northwest along the N.H. 02 until it meets the northwest corner of C.S. Dag No. 601.

The line then continues towards Moirang 1st part 1, Village No. 52, the line goes towards east covering the northern boundaries of C.S. Dag No. 67, 68, 81, 82, 96, 95, parts of 140 and goes south covering the eastern boundaries of C.S. Dag No. 101.

The line continues south towards Moirang 1st part 4, Village No. 52, covering the eastern boundaries of C.S. Dag No. 810, 755, 769 and crosses the road and meets the starting point.

WARD NO. 2

Starting from the southwest corner of C.S. Dag No. 771 of Moirang 1st part 4, Village No. 52, adjacent to the Moirang road, the ward boundary line goes towards north along the canal until it meets the northwest corner of C.S. Dag No. 776.

The line continues north towards Moirang 1st part 1, Village No. 52, covering the western boundaries of C.S. Dag No. 104, 103, 102 and goes towards northeast along the canal until it meets the C.S. Dag No. 903 of Moirang 1st part 5, Village No. 52.

The line then moves towards Moirang 1st part 5, Village No. 52, covering the western boundary of C.S. Dag No. 903 (pt) and turns towards east covering the northern boundaries of C.S. Dag No. 903 (Pt), 983, 979, 977 then continues towards south covering the eastern boundaries of C.S. Dag No. 1095, 955, 954. The line then crosses the road until it meets the northeast corner of C.S. Dag No. 943 and the line follows the river until it meets the southeast corner of C.S. Dag No. 923.

The line moves south towards Moirang 1st part 6, Village No. 52, the line continues south along the road and turns towards west along the Moirang Road until it meets the northeast corner of C.S. Dag No. 2605.

The line then continues towards Moirang 1st part 11, Village No. 52, the line goes west along the canal until it meets the southwest corner of C.S. Dag No. 2601 and moves towards north covering the western boundary of C.S. Dag No. 2601 and crosses the road until it meets the starting point.

WARD NO. 3

Starting from the southwest corner of C.S. Dag No. 1317 of Moirang 1st part 6, Village No. 52, adjacent to the Moirang road covering the western boundaries of C.S. Dag No. 1317.

The line continues towards Moirang 1st part 1, Village No. 52, covering the western boundaries of C.S. Dag No. 928, 930, 940 (Pt), 953, 1096 (Pt) until it reaches the road and turn

towards west along the road until it meets the southwest corner of C.S. Dag No. 986 then the line continues west covering the parts of C.S. Dag No. 903. The line continues north covering the western boundaries of C.S. Dag No. 903, 148 and continues towards east covering the northern boundaries of C.S. Dag No. 153 (Pt), 155 (Pt), 212, 155 (Pt) then continues south covering the eastern boundaries of C.S. Dag No. 165 and meets the Sendra road. The line continues southwest along the Sendra road until it reaches the southwest corner of C.S. Dag No. 199.

The line then continues towards Moirang 1st part 5, Village No. 52, the line goes southwest along the Sendra road until it reaches the southwest corner of C.S. Dag No. 1069 and continues south along the canal it reaches the southwest corner of C.S. Dag No. 1184. The line turns towards north along the road covering the C.S. Dag No. 1173, 1158 and crosses the Moirang road until it reaches the southwest corner of C.S. Dag No. 1237. The line then continues southwest along the Moirang road until it meets the starting point.

WARD NO. 4

Starting from the north-west corner of C.S. Dag No. 1160 of Moirang 1st part Village No. 52 (Sheet No. 5),adjacent to Moirang Road, the ward boundary line goes by covering the eastern boundaries of C.S. Dag Nos. 1159, 1172(part of) and turns east by crossing the C.S. Dag No. 1174 then turns south by covering the eastern boundary of C.S. Dag No. 1174 (part of) till it meet the north-east corner of C.S. Dag No. 1450 of Moirang 1st part Village No. 52.

From the north-east corner of C.S. Dag No. 1450 of Moirang 1st part Village No. 52 (Sheet No.6), the ward boundary line further continues south by covering the eastern boundaries of C.S. Dag Nos. 1450 (part of), 1446, 1445, 1442, 1441, 1439, 1438(part of), 1437 and meet the northeast corner of C.S. Dag No. 1991 of Moirang 1st part Village No. 52 (Sheet No.9).

From the north-east corner of C.S. Dag No. 1991 of Moirang 1st part Village No. 52 (Sheet No.9), the ward boundary line continues south by covering the eastern boundaries of C.S. Dag Nos. 1991, 1994, 1995, 962, 1960, 2071 and meet the north-east corner of C.S. Dag No. 2265 of Moirang 1st part Village No. 52 (Sheet No.10).

From the north-east corner of C.S. Dag No. 2265 of Moirang 1st part Village No. 52 (Sheet No.10), the ward boundary further continues south along the eastern boundary of C.S. Dag No. 2265 and turns west from the south-east corner of C.S. Dag No. 2265 till it meet the south-east corner of C.S. Dag No. of 1953 of Moirang 1st part Village No. 52 (Sheet No.9).

From the south-east corner of C.S. Dag No. of 1953 of Moirang 1st part Village No. 52 (Sheet No.9), the ward boundary turns west by covering the southern boundaries of C.S. Dag Nos. 1593, 1952, 1951, 950 and meet the south-east corner of C.S. Dag No. 2216 of Moirang 1st part Village No. 52 (Sheet No.10).

From the south-east corner of C.S. Dag No. 2216 of Moirang 1st part Village No. 52 (Sheet No.10), the ward boundary further continues west by covering the southern boundaries of C.S. Dag Nos. 2216, 2214, 2213, 2315, 2211 and turns south by covering the eastern boundary of C.S. Dag No. 2220. The boundary line then turns east by covering the northern boundary of C.S. Dag No. 2234 and then turns south by covering the eastern boundaries of C.S. Dag Nos. 2234, 2231, 2223 by touching the eastern boundary of C.S. Dag No. 2229 and meet the south-east corner of C.S. Dag No. 2657 of Moirang 1st part Village NO.52 (Sheet No.11).

From the south-east corner of C.S. Dag No. 2657 of Moirang 1st part Village NO.52 (Sheet No.11), the ward boundary line further continues west by covering the southern boundary of C.S. Dag No. 2657 and turns north by covering the western boundaries of C.S. Dag Nos. 2657, 2653, 2647 and meet the south-west corner of C.S. Dag No. 2209 by passing C.S. Dag No. 2206 of Moirang 1st part Village No. 52 (Sheet No.10).

From the south-west corner of C.S. Dag No. 2209 of Moirang 1st part Village No. 52 (Sheet No.10), the ward boundary further continues north by covering the western boundaries of C.S. Dag Nos. 2209, 2208, 2207, 2204 and turns east by covering the northern boundary of C.S. Dag No. 2204 till it meet the south-west corner of C.S. Dag No. 1945 of Moirang 1st part Village No. 52 (Sheet No.9).

From the south-west corner of C.S. Dag No. 1945 of Moirang 1st part Village No. 52 (Sheet No.9), the ward boundary line turns north by covering the western boundaries of C.S. Dag Nos. 1945, 1944, 1973, 1974, 1976, 1977, 1979, 1980, 1938, 1930 by touching the southern boundaries of C.S. Dag Nos. 1936, 1938 and meet the C.S. Dag No. 1433 of Moirang 1st part Village No. 52 (Sheet No.6).

Then the ward boundary turns west from the C.S. Dag No. 1433 of Moirang 1st part Village No. 52 (Sheet No.6) by covering the southern boundaries of C.S. Dag Nos. 1433, 1403, 1402, 1608, then turns north by covering the western boundaries of C.S. Dag Nos. 1608, 1401, 1338 and slightly turns west by covering the southern boundaries of C.S. Dag No. 1339. The boundary line turns south by covering the eastern boundaries of C.S. Dag Nos. 1342,1333, 1335, 1336 and turn west till it meet the eastern boundary of C.S. Dag No. 2613 of Moirang 1st part Village No. 52 (Sheet No.11) by covering C.S. Dag No. 1901 of Moirang 1st part Village No. 52 (Sheet No.9).

From the eastern boundary of C.S. Dag No. 2613 of Moirang 1st part Village No. 52 (Sheet No.11), the boundary line further continues west by covering the southern boundaries of C.S. Dag Nos. 2611, 2610, 2606 by touching the western boundaries of C.S. Dag Nos. 2611, 2620. The boundary line then turns north by covering the western boundaries of 2597 (part of), 2599 (part of), 2600 (part of), 2555 (part of) and turn east by passing the C.S. Dag Nos. 2600, 2605 till it meet the north-west corner of 2604 and meet the Moirang Road. The boundary line further continues east along the Moirang Road till it meets the starting point i.e. the north-west corner of C.S. Dag No. 1160 of Moirang 1st part Village No. 52 (Sheet No. 5).

WARD NO. 5

Starting from the northeastern corner of C.S. Dag No. 503 (Pt) of Moirang 2nd Part 2, Village No. 53, the ward boundary line goes towards east covering the northern boundary of C.S. Dag No. 503 (Pt) and goes south covering the eastern boundaries of C.S. Dag No. 503 (Pt).

The line continues south towards Moirang 2nd Part 4, Village No. 53, covering the eastern boundary of C.S. Dag No. 1506 (Pt) and turns towards west covering the part of C.S. Dag No. 1506.

The line then continues south towards Moirang 2^{nd} Part 5, Village No. 53, covering the eastern boundaries of C.S. Dag No. 2006, 2109 (Pt) and meets the road the line continues south along the road covering the eastern boundary of C.S. Dag No. 2093, 2019, 2085, 2082, 2081, 2077, 2075, 2074, 2073.

The line moves towards Moirang 2nd Part 6, Village No. 53, along the road covering the eastern boundaries of C.S. Dag No. 2607, 2506, 2531, 2527 and turns towards west along the road covering the southern boundaries of C.S. Dag No. 2527, 2528, 2534, 2502 then continues north covering the western boundaries C.S. Dag No. 2502.

The line then moves towards Moirang 2nd Part 5, Village No. 53, along the road covering the western boundaries of C.S. Dag No. 2063, 2062, 2056 and crosses the road.

The line continues towards Moirang 1st Part 5, Village No. 52, the line crosses the road and goes towards north along the canal covering the western boundaries of C.S. Dag No. 1076, 1075, 1073, 1070 then turns east and meets the Sendra road.

The line continues northwest along the Sendra road until it reaches the southwest corner of C.S. Dag No. 164 of Moirang 1st Part 1, Village No. 52, continues north covering the western boundaries of C.S. Dag No. 164 and turn east covering the northern boundaries of C.S. Dag No 164, 163 then turns towards south and meets the starting point.

WARD NO. 6

Starting from the northwest corner of C.S. Dag No. 2536 of Moirang 2nd Part 6, Village No. 53, the ward boundary line goes towards east covering the northern boundaries of C.S. Dag No. 2536, 2538, 2549 and turn towards north along the road covering the western boundaries of C.S. Dag No. 2525, 2524, 2523, 2522, 2507, 2508.

The line continues north towards Moirang 2nd Part 5, Village No. 53, covering the western boundaries of C.S. Dag No. 2078, 2079, 2080, 2083, 2084, 2088, 2089, 2090, 2092 and turns east covering the parts of 2109.

The line moves east towards Moirang 2nd Part 4, Village No. 53, covering the parts of C.S. Dag No. 1506 and turns south covering the eastern boundaries of C.S. Dag No. 1506 (Pt), 1507 (Pt) the turns west of same Dag No.

The line then moves east towards Moirang 2nd Part 6, Village No. 53, covering the parts of C.S. Dag No. 2574 and meets the Moirang - Kumbi road and goes towards north along the Moirang - Kumbi road until it meets the starting point.

WARD NO. 7

Starting from the southeastern corner of C.S. Dag No. 1532 of Moirang 1st Part 6, Village No. 52, adjacent to the Moirang – Kumbi road the ward boundary line goes towards west covering the southern boundaries of C.S. Dag No. 1529, 1528, 1527 and goes towards south along the road covering the C.S. Dag No. 1535, 1546.

The line continues south towards Moirang 1st Part 9, Village No. 52, covering the eastern boundaries of C.S. Dag No. 2014, 2012 and turns west covering the southern boundaries of C.S. Dag No. 2012 then goes towards north along the road covering the western boundaries of C.S. Dag No. 1112.

The line moves towards Moirang 1st Part 6, Village No. 52, along the canal covering the western boundaries of C.S. Dag No. 1462, 1551, 1549, 1539, 1537, 1478, 1438, 1478, 1450.

The line then moves north towards Moirang 1st Part 5, Village No. 52, covering the western boundaries of C.S. Dag No. 1185, 1184, 1153 and meets the Moirang - Kumbi road and goes towards south along Moirang - Kumbi road until it meets the starting point.

WARD NO. 8

Starting from the north-east corner of C.S. Dag No. 3501 of Moirang 2nd part Village No. 53(Sheet No. 8), the ward boundary goes south by covering the eastern boundaries of C.S. Dag Nos. 3501, 3546 and turns west by covering the southern boundary of C.S. Dag No. 3504 till it meets the south-east corner of C.S. Dag No. 3016 of Moirang 2nd part Village No. 53 (Sheet No.7).

From the south-east corner of C.S. Dag No. 3016 the boundary line further continues west by covering the southern boundaries of C.S. Dag No. 3016, 3067 and meets the Kumbi-Moirang Road. Then the ward boundary line turns North along the Kumbi-Moirang Road till meet the south-east corner of C.S. Dag No. 1815 of Moirang 1st part Village No. 52(Sheet No.8) and turn west by covering the southern boundary of C.S. Dag No. 1815 and meet the south-east corner of C.S. Dag No. 2081 of Moirang 1st part Village No. 52(Sheet No.9).

From the south-east corner of C.S. Dag No. 2081 of Moirang 1st part Village No. 52(Sheet No.9), the ward boundary line further continues west by covering the southern boundaries of C.S. Dag Nos. 2081, 2088, 2027, 2004 (part of), 2002 and turns south by covering the eastern boundaries of C.S. Dag No. 1999 by passing part of C.S. Dag No. 2001. Then the line turns west by covering the southern boundary of C.S. Dag No. 2000 and meet 1996(part of). The ward boundary then turns north by covering the western boundaries of C.S. Dag Nos. 1996 (part of), 1993(part of) till it meet the north-west corner of C.S. Dag No. 2007, then turns east by covering the northern boundary of C.S. Dag no. 2007 and then the boundary line turns north by covering the western boundaries of C.S. Dag Nos. 2028, 2011, 2015 and meet the south-west corner of C.S. Dag No. 1565 of Moirang 1st part Village No. 52(Sheet No.6) by passing the C.S. Dag No. 1564 of same cadastral.

From the south-west corner of C.S. Dag No. 1565 of Moirang 1st part Village No. 52(Sheet No.6), the ward boundary turns north by covering the western boundaries of C.S. Dag Nos. 1564, 1577, 1578, 1579, 1534, 1533 and then turns east by covering the northern boundary of C.S. Dag Nos. 1533 and meet the Kumbi-Moirang Road. From the north-east corner of C.S. Dag No. 1533, the ward boundary continues straight toward east crossing the Kumbi-Moirang Road, by passing the C.S. Dag Nos. 2580, 1507 of Moirang 2nd part Village No. 53(Sheet No.6) and Moirang 2nd part Village No. 53 (Sheet No.4) respectively. The boundary line turns south along the eastern boundary of C.S. Dag No. 1507 and meet the starting point i.e. north-east corner of C.S. Dag No. 3501 of Moirang 2nd part Village No. 53(Sheet No. 8).

WARD NO.9

Starting from the north-west corner of C.S. Dag No. 3068 of Moirang 2nd part Village No.53 (Sheet No. 7), adjacent Kumbi-Moirang Road, the ward boundary line continues east by covering the northern boundary of C.S. Dag No. 3068, 3069 till it meets the north-west corner of C.S. Dag No. 3546 of Moirang 2nd part Village No.53 (Sheet No. 8).

From the north-west corner of C.S. Dag No. 3546 of Moirang 2^{nd} part Village No.53 (Sheet No. 8), the ward boundary line continues east by covering the northern boundary of C.S. Dag No. 3546 and turns south by covering the eastern boundary of C.S. Dag No. 3545, 3507, 3513, 3514, 3519 till meet the south-west corner of C.S. Dag No. 3517 and turns north by covering the western boundaries of C.S. Dag No. 3517. The boundary line then turns west by covering the southern boundaries fo C.S. Dag Nos. 3513, 3551 and meet the south-east corner of C.S. Dag No. 3030 of Moirang 2^{nd} part Village No.53 (Sheet No. 7).

From the south-east corner of C.S. Dag No. 3030 of Moirang 2nd part Village No.53 (Sheet No. 7), the ward boundary line continues west by covering the southern boundaries of C.S. Dag Nos. 3030, 3031, 3035, 3027, 3026, 3025 and meet the Kumbi-Moirang Road and turns slightly south till it meet the south-east corner of C.S. Dag No. 2270 of Moirang 1st part Village No. 52 (Sheet No.10).

From the south-east corner of C.S. Dag No. 2270 of Moirang 1st part Village No. 52 (Sheet No.10), the ward boundary turns west by covering the southern boundaries of C.S. Dag Nos. 2270, 2269, 2267, 2266 and meet the south-west corner of C.S. Dag No. 2085 of Moirang 1st part Village No. 52 (Sheet No. 9).

From the south-west corner of C.S. Dag No. 2085 of Moirang 1st part Village No. 52 (Sheet No. 9), the ward boundary turns north by covering the western boundaries of C.S. Dag Nos. 2085, 2091, 2084, 2072, 308, 2063, 961, 1996 (part of) till it meet the north-west corner of C.S. Dag No. 1997. Then the boundary line turns east by covering the northern boundaries of C.S. Dag Nos. 1997, 1998 and meet the north-west corner of C.S. Dag No. 2033 by passing part of C.S. Dag No. 1999. Then the boundary line turns north by covering the western boundaries of C.S. Dag Nos. 2032, 2031, 2030 and turns east by touching some part of C.S. Dag No. 2001,2004 and covering the northern boundary of C.S. Dag No. 2008 and meet the north-west corner of C.S. Dag No. 1817 of Moirang 1st part Village No.52(Sheet No.8).

From the north-west corner of C.S. Dag No. 1817 of Moirang 1st part Village No.52(Sheet No.8), the ward boundary further continues east by covering the northern boundaries of C.S. Dag Nos. 1817, 1816 and meet the Kumbi-Moirang Road. The ward boundary line turns south along the Kumbi-Moirang Road till it meet the starting point i.e. the north-west corner of C.S. Dag No. 3068 of Moirang 2nd part Village No.53 (Sheet No. 7).

WARD NO. 10

Of Starting from the north-east corner of C.S. Dag No. 2395 of Ngangkha Lawai Village No. 51 (Sheet No. 3), adjacent to NH-2, the ward boundary goes south-west along the NH-2 till it meet the south-east corner of C.S. Dag No. 2448, then the ward boundary turns west by covering the southern boundaries of C.S. Dag Nos. 2448, 2449, 2451, 2437, 2436 and turns north by covering the western boundaries of C.S. Dag Nos. 2436, 2582, 2435, 2404. The ward boundary turns east by covering the northern boundaries of C.S. Dag Nos. 2404, 2439, 2442, 2443, then turns north by covering the western boundaries of C.S. Dag Nos. 2425, 2426, 2427. The ward boundary line turns west by covering the southern boundaries of C.S. Dag Nos. 2409, 2354, 2353 and then turns north by covering the western boundaries of C.S. Dag Nos. 2353, 2267, 2260, 2362, 2364, 2585, 2251, 2253, 2246 by touching the northern boundaries of C.S. Dag Nos. 2260, 2358, 2246 and eastern boundary of C.S. Dag No. 2260 till it meet the NH-2. The ward boundary turns south-east along the NH-2 and meet the starting point i.e. the north-east corner of C.S. Dag No. 2395 of Ngangkha Lawai Village No. 51 (Sheet No. 3).

WARD NO. 11

Starting from the north-west corner of C.S. Dag No.3010 of Ngangkha Lawai Village No. 51(Sheet No.4) adjacent to NH-2, the ward boundary line continues south by covering the eastern boundaries of C.S. Dag No. 3010, 3011, 3012, 3013, 3014, 3016, 3017, 3023,3024, 3043, 3060, 3030. Then the boundary line turns west by covering the southern boundary of C.S. Dag No. 3089,3090, 3248 till it meets the south-east corner of C.S. Dag No. 2253 of Ngangkha Lawai Village No. 51(Sheet no.3) by crossing the NH-2.

From the south-east corner of C.S. Dag No. 2253 of Ngangkha Lawai Village No. 51(Sheet no.3), the ward boundary line continues west by covering the southern boundaries of C.S. Dag Nos. 2533, 2534 and turns north by covering the western boundaries of C.S. Dag Nos. 2534, 2500, 2501, 2492, 2490, 2487, 2486 and then turns east by covering the northern boundaries of C.S. Dag Nos. 2486, 2484, 2461,2460, 2453, 2454 till it meet the NH-2. Then the boundary line turns north along the NH-2 and meet the starting point i.e. the north-west corner of C.S. Dag No.3010 of Ngangkha Lawai Village No. 51(Sheet No.4).

WARD NO. 12

Starting from the north-west corner of C.S. Dag No. 3035 of Moirang 2^{nd} Part Village No. 53 (Sheet No.7), the ward boundary line continues east by covering the northern boundary of C.S. Dag Nos. 3035, till it reaches the north-west corner of C.S. Dag No. 3214 of Moirang 2^{nd} Part Village No. 53 (Sheet No. 8).

From the north-west corner of C.S. Dag No. 3214 of Moirang 2nd Part Village No. 53 (Sheet No. 8), the line continues along the eastern boundary of C.S. Dag No.3214 till it meets the northeast corner of C.S. Dag No. 3576. The boundary line further continues south by covering the eastern boundary of C.S. Dag No. 3576 till it meets the southern boundary of C.S. Dag No. 3519 (part of). Then the boundary line turns west along the southern boundary of C.S. Dag No. 3519 till

it meets the south-east corner of C.S. Dag No. 3024 and till it meet the north-east corner of C.S. Dag No. 3527 and turns south to meet the north-east corner of C.S. Dag No. 6030 of Moirang 2nd part Village No. 53 (Sheet No. 13).

From the north-east corner of C.S. Dag No. 6030 of Moirang 2nd part Village No. 53 (Sheet No. 13), the boundary line further continues south by covering the eastern boundaries of C.S. Dag Nos. 6030, 6027 and turns west by covering the southern boundary of C.S. Dag No. 6027 till it meet the Kumbi-Moirang Road. The boundary line continues south along the Kumbi-Moirang Road till it meet the north-west corner of C.S. Dag No. 6064 and turns east till it meet the southwest corner of C.S. Dag No. 6170. Then the boundary line turns north by covering the western boundary of C.S. Dag No. 6170 and turns east by covering the northern boundaries of C.S. Dag Nos. 6170, 6051, 6052, 6053, 6061, 6060 by touching the eastern boundary of C.S. Dag No. 6053. The boundary line then turns north by covering the western boundaries of C.S. Dag Nos. 6059, 6058, 6057, 6056, 6045, 6044, 6043 and turns east by covering the northern boundaries of C.S. Dag Nos. 6043, 6065. The boundary line then turns south by covering the eastern boundaries of C.S. Dag Nos. 6065, 6085, 6082, 6079, 6078 by touching the northern boundaries of C.S. Dag Nos. 6085, 6080 and southern boundary of C.S. Dag No. 6082. The boundary line turns toward west by covering the southern boundaries of C.S. Dag Nos. 6078, 6076, 6074, 6073, 6071 and meet the Kumbi-Moirang Road. The boundary line turns south till it meet the north-west corner of C.S. Dag No. 6128 and turns east by covering the northern boundaries of C.S. Dag Nos. 6128, 6143, 154, 6156 (part of). The boundary line then turns south by covering the eastern boundary of C.S. Dag no. 6156 till it meet the south-east corner of C.S. Dag No. 6551 and turns north by covering the western boundary of C.S. Dag No. 6151 till it meet the south-east corner of C.S. Dag No. 6140. Then the line turns west by covering the southern boundary of C.S. Dag No. 6140 and meet the north-east corner of C.S. Dag No. 6412 of Moirang 2nd part Village No. 53 (Sheet No. 14).

From the north-east corner of C.S. Dag No. 6412 of Moirang 2nd part Village No. 53 (Sheet No. 14), the ward boundary line further continues west by covering the southern boundaries of C.S. Dag Nos. 6412, 6515, 6509, 6507, 6508 and then turns south by covering the eastern boundaries of C.S. Dag Nos. 6502, 6518, 6519, 6521, 6522 by touching the northern boundary of C.S. Dag No. 6505. Then the boundary line turns west by covering the southern boundary of C.S. Dag No. 6522, 6523 (part of) and crosses the Kumbi-Moirang Road till it meet the south-east corner of C.S. Dag No. 7020 by passing part of C.S. Dag No. 7081 of Moirang 2nd part Village No. 53 (Sheet No. 15).

From the south-east corner of C.S. Dag No. 7020 of Moirang 2nd part Village No. 53 (Sheet No. 15), the boundary line continues west and turns north along the C.S. Dag No. 7020 till it meets the south-west corner of C.S. Dag No. 7024. The ward boundary line further continues north by covering the western boundaries of C.S. Dag. Nos. 7024, 7022, 7021, 7018 and meet the Kumbi-Moirang Road. The line then further continues along the Kumbi-Moirang Road till it meets the south-east corner of C.S. Dag No. 7007 and turns west by covering the southern boundary of C.S. Dag No. 7007. The boundary line again turns north by covering the western boundaries of C.S. Dag Nos. 7002, 7003 and meet the north -west corner of C.S. Dag No. 6018 of Moirang 2nd part Village No. 53 (Sheet No.13).

From the north -west corner of C.S. Dag No. 6018 of Moirang 2nd part Village No. 53 (Sheet No.13), the ward boundary line turns east by covering the northern boundary of C.S. Dag No. 6018

till it meet the Kumbi-Moirang Road and then turns north along the Kumbi-Moirang Road till it meet the south-east corner of C.S. Dag No. 6007. Then the boundary line turns west by covering the southern boundaries of C.S. Dag Nos. 6007, 6005 and the line turns north by covering the western boundaries of C.S. Dag Nos. 6005, 6004, 6003 till it meet the south-west corner of C.S. Dag No. 3044 of Moirang 2nd Part Village No. 53 (Sheet No.7) and continues north till it touches the south-east corner of C.S. Dag No. 2287 of Moirang 1st part Village No. 52 (Sheet No.10).

From the south-east corner of C.S. Dag No. 2287 of Moirang 1st part Village No. 52 (Sheet No.10), the ward boundary line turns west by covering the southern boundaries of C.S. Dag Nos. 2287, 2293, 2320, 2295, 2297, 2239, 2236, then turns north by covering the western boundary of C.S. Dag No. 2237. The boundary line again turns east by covering the northern boundaries of C.S. Dag Nos. 2218, 2217, 2254, 2262 (part of), 2263 (part of), 2264(part of), 2265(part of), 2271 and meet the Kumbi-Moirang Road. The boundary line turns north along the Kumbi-Moirang Road till it meet the starting point i.e. the north-west corner of C.S. Dag No. 3035 of Moirang 2nd Part Village No. 53 (Sheet No.7).
