No.SCS-401/6/2025-MAHUD-MAHUD/15: Whereas, Town Planning Department, Manipur in collaboration with the Oinam Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Oinam Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Oinam Municipal Council in its meeting held on 02.12.2024 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the OinamMunicipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Bishnupur in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED OINAM MUNICIPAL AREA

Starting from the northwest corner of C.S. Dag No. 272 Maibam Village No. 23, Sheet No. 1, Adjacent to the N.H. 02, the boundary line goes towards east covering northern boundaries of C.S. Dag No. 272, 271, 274, 277 and turn south.

The line continues east of Oinam Village No. 30, Sheet No. 2 covering C.S. Dag No. 1010, 1027, 1028, 1029, 1292, 1031, 1032.

The line then continues east of Village No. 23, Maibam, Sheet No. 1, covering northern boundaries of C.S. Dag No. 378, 379, 380, 381, 382 and goes south covering C.S. Dag No. 383, 385 and goes towards Village No. 23, Maibam, Sheet No.2, covering C.S. Dag No. 1644 and turn west covering C.S. Dag No. 403, 402, 398, 397, 396, 395.

Further, the line goes west of Village No. 30, Oinam, Sheet No. 2 covering C.S. Dag No. 1041, 1282 and continues towards south covering C.S. Dag No. 1044, 1045, 1078, 1079, 1092, 1307, 1093 then goes east covering C.S. Dag No. 1118, 1229, 1231 and goes south covering C.S. Dag No. 1231, 1230, 1229, 1235, 1242, 1251, 1252, 1253, 1206, 1207, 1204, 1200, 1199, 1197, 1177.

The line continues south of Village No. 30, Oinam, Sheet No. 1 covering C.S. Dag No. 777. The line then continues south of Village No. 30, Oinam, Sheet No. 3 covering C.S. Dag No. 2088 and turn west covering C.S. Dag No. 2088, 2087, 2085.

The line moves towards west of Village No. 30, Oinam, Sheet No. 1, covering C.S. Dag No. 776, 766, 767, 768, 769, 772 and turn towards north covering C.S. Dag No. 754 then goes west covering C.S. Dag No. 435, 431, 429, 421, 799, 422, 417, 418, 419, 485, 488, 489, 490, 413 and cross the N.H. 02, 262, 263, 276, 279 and goes north covering C.S. Dag No. 279, 278, 240, 246, 247, 249, 201, 203, and along the canal 191 and turn east covering C.S. Dag No. 169, 173, 175 and goes north covering C.S. Dag No. 157, 146, 137, 135, 132, 111, 114, 119, 120 and turn east covering C.S. Dag No. 120, 122.

The line continues towards east of Village No. 30, Oinam, Sheet No. 2, covering C.S. Dag No. 1001, 1002 and turn south covering C.S. Dag No. 1003, 1004, 1005 and cross the N.H. 02, meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED OINAM MUNICIPAL AREA

WARD NO. 1

Starting from the northwest corner of C.S. Dag No. 271 of Village No. 23, Maibam, Sheet No. 1, the ward boundary line goes towards east covering C.S. Dag No. 274, 277 and turn south.

The line continues east towards Village No. 30, Oinam, Sheet No. 2, covering C.S. Dag No. 1010, 1027, 1028, 1029, 1292, 1031, 1032.

The line then continues east towards Village No. 23, Maibam, Sheet No. 1, covering northern boundaries of C.S. Dag No. 378, 379, 380, 381, 382 and goes south covering C.S. Dag No. 383, 385 and goes towards Village No. 23, Maibam, Sheet No.2, covering C.S. Dag No. 1644 and turn west covering C.S. Dag No. 403, 402, 398, 397, 396, 395.

Further the line continues west towards Village No. 30, Oinam, Sheet No. 2, covering C.S. Dag No. 1041, 1282, 1043, 1048, 1047, 1059 and goes north covering C.S. Dag No. 1059, 1052 cross the road and covering C.S. Dag No. 1018, 1017, 1015, 1014, 1013, 1009.

Then continues towards Village No. 23, Maibam, Sheet No. 1, covering C.S. Dag No. 274, 271, meets the starting point.

WARD NO. 2

Starting from the northwest corner of C.S. Dag No. 272 of Village No. 23, Maibam, Sheet No. 1, the ward boundary line goes towards east covering C.S. Dag No. 272 and goes south covering C.S. Dag No. 273.

The line continues south towards C.S. Dag No. Village No. 30, Oinam, Sheet No. 1, covering C.S. Dag No. 596, 599, 602, 605.

Further, the line continues south towards Village No. 30, Oinam, Sheet No. 2, covering C.S. Dag No. 1056, 1053, 1285, 1284, 1295, 1283, 1058 and turn east covering C.S. Dag No. 1062, 1061, 1060, 1046, 1044 then continues south covering C.S. Dag No. 1044, 1045, 1078 and goes west covering C.S. Dag No. 1078, 1077, 1075, 1074, 1073, 1072, 1068. The line goes south covering C.S. Dag No. 1067, 1084, 1085, 1086, 1087, 1088 and turn west covering C.S. Dag No. 1088 then turn north covering western boundaries of C.S. Dag No. 1088, 1087, 1085, 1084, 1067, 1066, 1306, 1287, 1286, 1064, 1057, 1056.

The line moves west towards Village No. 30, Oinam, Sheet No. 1, along the road covering C.S. Dag No. 605, 604, 590, 589, 588, 587, 585 cross the N.H. 02 and goes west covering C.S. Dag No. 178 then goes north covering C.S. Dag No. 157, 146, 137, 135, 132, 111, 114, 119, 120 and turn east covering C.S. Dag No. 120, 122.

The line continues east towards Village No. 30, Oinam, Sheet No. 2, covering C.S. Dag No. 1001, 1002 and turn south covering C.S. Dag No. 1003, 1004, 1005 and cross the N.H. 02, meets the starting point.

WARD NO. 3

Starting from the northeast corner of C.S. Dag No. 179 of Village No. 30, Oinam, Sheet No. 1, adjacent to the N.H. 02, the ward boundary line goes towards south along the road covering C.S. Dag No. 179, 181 and goes east covering C.S. Dag No. 547, 548, then turn towards south covering C.S. Dag No. 546, 544, 543, 554, 540, 539, 538, 536, 797, 530, 524, 786, 525, 520, 517, 516, 515 cross the N.H. 02, covering C.S. Dag No. 258, 262, then continues west covering C.S. Dag No. 263, 276, 279 and goes north covering C.S. Dag No. 279, 278, 240, 246, 247, 249, 201, 203, and along the canal 191 and turn east covering C.S. Dag No. 169, 173, 175, 176, 177, 179, meets the starting point.

WARD NO. 4

Starting from the northeast corner of C.S. Dag No. 646 of Village No. 30, Oinam, Sheet No. 1, the ward boundary line goes towards south along the road covering C.S. Dag No. 648, 649, 650, 651, 464, 463, 462, 461, 460, 459, 458, 457 and turn east covering C.S. Dag No. 454, 421, 799, 422, 417, 418, 419, 485, 488, 489, 490 then goes north covering C.S. Dag No. 490, 491, 498, 499, 501, 514, 513, 512, 518, 519, 526, 527, 528 and goes east covering C.S. Dag No. 529, 647, meets the starting point.

WARD NO. 5

Starting from the northeast corner of C.S. Dag No. 1167 of Village No. 30, Oinam, Sheet No. 2, the ward boundary line goes towards south along the road covering C.S. Dag No. 1167, 1168.

The line continues south towards Village No. 30, Oinam, Sheet No. 1, covering C.S. Dag No. 739, 741, 743, 744, 748, 749, 752, 761, 760, 758, 766, 776.

The line then continues towards Village No. 30, Oinam, Sheet No. 3, covering C.S. Dag No. 2087, 2088 and goes west covering C.S. Dag No. 2088, 2087, 2085.

The line moves west towards Village No. 30, Oinam, Sheet No. 1, covering C.S. Dag No. 776, 766, 767, 768, 769, 772 and turn towards north covering C.S. Dag No. 754, 718, 719, 720, 721, 722, 723, 724, 724, 725, part of 607, 606, meets the starting point.

WARD NO. 6

Starting from the northwest corner of C.S. Dag No. 1163 of Village No. 30, Oinam, Sheet No. 2, the ward boundary line goes east covering C.S. Dag No. 1154, 1221, 1220, 1216, 1251 and goes south covering C.S. Dag No. 1251, 1252, 1253, 1206, 1204, 1200, 1199, 1197, 1177.

The line continues towards Village No. 30, Oinam, Sheet No. 1, covering C.S. Dag No. 777, 765, 762.

The line continues towards Village No. 30, Oinam, Sheet No. 2, covering eastern boundaries of C.S. Dag No. 1173, 1303, 1302, 1172, 1308, 1169, 1165, meets the starting point.

WARD NO. 7

Starting from the northwest corner of C.S. Dag No. 1098 of Village No. 30, Oinam, Sheet No. 2, along the road, the ward boundary line goes east covering C.S. Dag No. 1098, 1089, 1090, 1082, 1311, 1081, 1080, 1079, 1092, 1307, 1093 then goes east covering C.S. Dag No. 1118, 1229, 1231 and goes south covering C.S. Dag No. 1231, 1230, 1229, 1235, 1242 and goes west along the road covering C.S. Dag No. 1242, 1241, 1240, 1223, 1224, 1300, 1153, 1150, 1149, 1145, 1144, 1143, 1141 then continues towards north covering C.S. Dag No. 1141, 1140, 1139, 1138, 1137, 1136, 1291, 1103, 1100, 1099, 1098, meets the starting point.

WARD NO. 8

Starting from the northeast corner of C.S. Dag No. 663 of Village No. 30, Oinam, Sheet No. 1, the ward boundary line goes south covering C.S. Dag No. 664, 607, 715, 717, 439, 438, 437, 435 and goes west covering C.S. Dag No. 435, 431, 429 then goes north covering C.S. Dag No. 429, 430, 431, 446, 448, 453, 452, 450, 688, 687, 685, 684, 683, 682, 681, 652, 653, 654, 655, 656, 657, 644 and turn east along the road covering C.S. Dag No. 643, 642, meets the starting point.

WARD NO. 9

Starting from the northwest corner of C.S. Dag No. 580 of Village No. 30, Oinam, Sheet No. 1, the ward boundary line goes east along the road covering C.S. Dag No. 583 and goes south covering C.S. Dag No. 607, 608, 607 and cross the road towards east covering C.S. Dag No. 637, 641, 558, 534 then continues towards north covering C.S. Dag No. 534, 535, 789, 553, 552, 550, 549, 573, 574, 579, 580, meets the starting point.
