Imphal, the 3rd November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/7: Whereas, Town Planning Department, Manipur in collaboration with the Lamlai Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Lamlai Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Lamlai Municipal Council in its meeting held on 24.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Lamlai Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Imphal East in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED LAMLAI MUNICIPAL AREA

Part A:

Strating from the south western corner of C.S Dag No. 11 of Chalou Village No. 67 (Ward No. 1), adjacent to N.H. 202, the Municipal boundary line goes towards north-east along the western boundaries of C.S. Dag Nos. 11, 10, 9, 8, 6, 5, 4 and continues towards east along the northern boundaries of C.S. Dag Nos. 3, 44, 98 then goes south covering the eastern boundaries of C.S Dag Nos. 108, 114, 119, 126, 127 and slightly goes west along the road covering the southern boundaries of C.S Dag No. 87 and meets the northeastern corner of C.S Dag No. 42.

The line goes south of Village No. 66 Lamlai, covering the eastern boundaries of C.S Dag Nos. 84, 74, 75, 76, 72, 68 and continues east covering the northern boundaries of C.S Dag No. 117, 120, 121, 122 then goes towards south covering the eastern boundaries of C.S Dag Nos. 123, 119, 127, 356, 355, 346, 345, 314, 327, 330, 331, 332, 333, 334, 1063, 1060, 1061. The line goes north covering the western boundaries of C.S Dag Nos. 1061, 1062, 1054, 334, 333, 332, 250, 265, 200, 176, 177, 178 and continues towards west covering the southern boundaries of C.S Dag Nos. 8, 7, 412, 6, 5, 4, 2 and crosses the road to meets the starting point.

Part B:

The line starting from northeast corner of C.S Dag No. 109 of Village No. 58, Napet (Part of Ward No.4) goes towards south covering the eastern boundaries of C.S Dag Nos. 110, 114, 118, 126, 127 and continues towards west covering the southern boundaries of C.S Dag Nos. 127, 130, 132, 138, 123, 144, 96, 95, 85. Then continues towards north covering the western boundaries of C.S Dag Nos.70, 68 and turns east covering the northern boundaries of C.S Dag Nos. 67, 66, 90, 197, 58, 59, 53,105, 112, 113 and slightly turn north covering the western boundaries of C.S Dag Nos. 114, 110 and 109 meeting the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED LAMLAI MUNICIPAL AREA

WARD NO. 1

Starting from the south-western corner of C.S. Dag No. 11 of Village No. 67 Chalou, adjacent to N.H. 202, the ward boundary line goes towards north-east along the eastern boundaries of C.S. Dag Nos. 11, 10, 9, 8, 6, 5, 4 and continues towards east along the northern boundaries of C.S. Dag Nos. 3 and 44. The boundary line goes towards south along the eastern boundaries of C.S. Dag Nos. 44, 45, 47, 51, 52, 56, 55, 174, 86, 84, 83, 61, 19, 201, 63, 191, 65 and then continues towards west along the road covering the southern boundaries of C.S. Dag Nos. 65, 34, 22, 21, 14, 13, meeting the starting point.

WARD NO. 2

Starting from the north-eastern corner of C.S. Dag No. 98 of Village No. 67 Chalou , the ward boundary line goes towards south along the eastern boundaries of C.S. Dag Nos. 98, 97, 100, 96, 95, 185, 94, 93, 92, 178, 177, 176, 91, 90, 186, 89, 204, 79 and continues towards west along the road covering the southern boundaries of C.S. Dag Nos. 79, 78, 77, 76, 75, 74, 73, 72, 71, 70, 69, 65. The line then goes

towards north along the western boundaries of C.S. Dag Nos. 62, 183 and 184, then continues towards east along the northern boundaries of C.S. Dag Nos. 184 and 82. The boundary line goes towards north along the road covering the western boundaries of C.S. Dag Nos. 204, 89, 186, 90, 91, 176, 177, 178, 92 and goes west covering the southern boundaries of C.S. Dag Nos. 198, 54 then turn towards north covering the western boundaries of C.S. Dag Nos. 53, 194, 193, 50, 196, 195, 49, 48, 98 meeting the starting point.

WARD NO. 3

Starting from the north – western corner of C.S. Dag No. 2 of Village No. 66 Lamlai, adjacent to the N.H. 202, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 2, 1, 4, 5, 6, 412, 7, 12, 13, 36, 39, 41, 43 and goes south along the road covering the eastern boundaries of C.S. Dag Nos. 45, 38, 34, 31. Then the line goes east covering the northern boundaries of C.S. Dag Nos. 57, 56 and goes south along the road covering the eastern boundaries of C.S. Dag Nos. 56, 392, 59, 60, 61, 62, 63, 64, 65, 67, 68 the turn towards west along the canal covering the southern boundaries of C.S. Dag Nos. 400, 22, 20, 8, 7, 412, 6, 5, 3, 2 and meeting the starting point.

WARD NO. 4

Part A:

Starting from the south – western corner of C.S. Dag No. of Village No. 67 Chalou, adjoining to the N.H. 202, the ward boundary line goes towards north along the road covering the western boundaries of C.S. Dag Nos. 88, 121, 120, 189, 114, 108 and goes east of same Dag No. then turn towards south covering the eastern boundaries of C.S. Dag Nos. 108, 114, 119, 126, 127 and slightly goes west along the road covering the southern boundaries of C.S. Dag No. 87. and meets the northeastern corner of C.S. Dag No. 42.

The line goes south of Village No. 66 Lamlai, covering C.S. Dag No. 84, and turn west covering the southern boundaries of C.S. Dag Nos. 84, 74, 75, 76, 72 and crosses the road until it meets southeast corner of C.S. Dag No. 55 and 394. Then the line continues north covering the western boundaries of C.S. Dag Nos. 394, 54, 395, 53, 52, 42, 48 and turn slightly towards east and meets the starting point.

Part B:

On another side the ward boundary line starts from the north east corner of C.S. Dag No. 109 of Village No. 58 Napet, the line goes towards south covering the eastern boundaries of C.S. Dag Nos. 109, 110, 114, 118, 117 and goes west along the road covering the southern boundaries of C.S. Dag Nos. 84, 118, 119, 121, 204, 190, 102, 100, 101, 105 then turn towards east covering the northern boundaries of C.S. Dag Nos. 105, 112, 113 and continues north covering the western boundaries of C.S. Dag Nos. 114, 110 109 and meets the starting point.

WARD NO. 5

Starting from the northeast corner of C.S Dag No. 126 of Village No. 58 Napet, the ward boundary line goes towards south covering the eastern boundaries of C.S Dag Nos. 126, 127 and continues towards west covering the southern boundaries of C.S Dag Nos. 127, 130, 132, 138, 123, 144, 96, 95, 85. Then continues towards north covering the western boundaries of C.S Dag Nos. 70, 68 and turns east covering the northern boundaries of C.S Dag Nos. 67, 66, 90, 197, 58, 59, 53 then continues south covering the eastern boundaries of C.S Dag Nos. 54, 55, 58, 56, 92 and goes east covering the northern boundaries of C.S Dag Nos. 98, 142, 141, 192, 136, 122 and meets the starting point.

WARD NO. 6

Starting from the northwest corner of C.S Dag No. 120 of Village No. 66 Lamlai, the ward boundary line goes towards east covering the northern boundaries of C.S Dag Nos. 120, 121, 122 and turn towards south covering the eastern boundaries of C.S Dag Nos. 123, 119, 127 then the line goes towards west covering the southern boundaries of C.S Dag Nos. 304, 421, 303, 273. The line continues towards north covering the western boundaries of C.S Dag Nos. 273, 275, 278, 289, 288, 144, 145, 146, 147, 119 and meets the starting point.

WARD NO. 7

Starting from the southwest corner of C.S. Dag No. 177 of Village No. 66 Lamlai, the ward boundary line goes towards north covering the western boundaries of C.S. Dag Nos. 177, 178, 180 and goes towards east covering the northern boundaries of C.S. Dag Nos. 180, 177 then turn south covering the eastern boundaries of C.S. Dag Nos. 118, 148, 149, 150, 151, 152, 286, 285, 284, 283, 282, 281, 279. The line then continues north along the road until it meets southeast corner of C.S. Dag No. 168 and goes west covering the southern boundaries of C.S. Dag Nos. 168, 174 and meets the starting point.

WARD NO. 8

Starting from the northeast corner of C.S. Dag No. 169 of Village No. 66 Lamlai, the ward boundary line goes towards south along the road covering the eastern boundaries of C.S. Dag Nos. 170, 171, 172, 270, 386, 387, 271, 264, 263, 262, 261, 402, 401, 260, 259, 258, 257, 255, 254, 253, 252, 251, 250 and goes west covering the southern boundaries of C.S. Dag No. 250. The line then turns towards north covering same C.S. Dag Nos. 250, 265, 200, 176, and turn east covering the northern boundaries of C.S. Dag Nos. 176, 173, meeting the starting point.

WARD NO. 9

Starting from the northwest corner of C.S. Dag No. 308 of Village No. 66 Lamlai, alongside the road the ward boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 385, 306, 356 and goes south covering the eastern boundaries of C.S. Dag Nos. 355, 346, 345, 314, 327, 330, 331, 332, 333, 334, 1063, 1060, 1061 then goes north covering the western boundaries of C.S Dag Nos. 1061, 1062, 1054, 334, 333, 332, 256, 324, 399, 323, 322, 319, 318, 315, 313, 312, 309 meeting the starting point.
