No.SCS-401/6/2025-MAHUD-MAHUD/17: Whereas, Town Planning Department, Manipur in collaboration with the Sekmai Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Sekmai Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Sekmai Municipal Council in its meeting held on 24.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Sekmai Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Imphal West in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED SEKMAI MUNICIPAL AREA

Starting from northwestern corner of C.S. Dag No. 2953 of Village No. 30, Sheet No. 6 of Sekmai (ward No. 1), adjacent to N.H. 02, the boundary line goes towards east covering northern boundaries of C.S. Dag Nos. 2953, 3038 and goes south covering eastern boundaries of C.S. Dag Nos. 3096, 3097, 3098, 3085, 3065, 3066, 3068, 3069, 3040, 3041, 3038, 3165, 3164, 3163.

The line continues towards Sheet No. 1 of Maharabi Village No. 29, covering the eastern and southern boundary of C.S. Dag No. 19 and cross the N.H. 02 meets the south east corner of C.S. Dag No. 1.

Further, the line continues west, towards the Village No. 30 Sekmai, Sheet No. 7, covering the southern boundaries of C.S. Dag Nos. 3592, 3590, 3589, 3582, 3581, 3580, 3579.

The line then continues north, towards the Village No. 30 Sekmai, Sheet No. 6, along the road covering the western boundaries of C.S. Dag Nos. 2753, 2757, 2754, 2755, 2754, 2753, 2752, 2700, 2699, 2698, 2697, 2696, 2695, 2694, 2693, 2692, 2691.

Further the line continues towards Village No. 30 Sekmai, Sheet No. 5, covering western boundaries of C.S. Dag Nos. 2381, 2380, 2379, 2376, 2375, 2372, 2371, 2368, 2367, 2270, 2255, 2256, 2262, 2267, 2107, part of 2270 and part of 2299, then continues east covering the northern boundaries of C.S. Dag Nos. 2301, 2303 and slightly goes south covering the eastern boundaries of C.S. Dag Nos. 2295, 2294 and goes east along the road covering the northern boundaries of C.S. Dag Nos. 2306, 2313.

The line again moves east, toward the Village No. 30 Sekmai, Sheet No. 6, covering northern boundaries of C.S. Dag Nos. 2509, 2508, 2512 and goes south covering eastern boundaries of C.S. Dag Nos. 2513, 2514, 2520, 2521, 2522, 2523, 2524, 2525, 2556, 2551, 2558, 2578, 2559, 2578, 2560, 2561, 2562, 2480, 2481, and cross the N.H.02 and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED SEKMAI MUNICIPAL AREA

WARD NO. 1

Starting from the northwest corner of C.S. Dag No. 2953, adjacent to N.H. 02 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes towards east covering northern boundaries of C.S. Dag Nos. 2953, 3038 and goes south covering eastern boundaries of C.S. Dag Nos. 3096, 3097, 3098, 3085, 3065, 3066, 3068, 3069, 3040, 3041, 3038, 3165, 3164, 3163.

The line continues towards Village No. 29 Maharabi, Sheet No. 1, covering the eastern and southern boundary of C.S. Dag No. 19 and goes north along the road covering the western boundaries of C.S. Dag Nos. 3162, 3147, 3156, 3144, 31241, 3140, 3139, 2935, 2944, 2945, 2947, 2952, 2183 and meet the starting point C.S. Dag No. 2953.

WARD NO. 2

Starting from the northeast corner of C.S. Dag No. 2841, adjacent to N.H. 02, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag Nos. 2842, 2843 and goes west along the road covering the southern boundaries of C.S. Dag Nos. 2827, 2828, 2829, 2830, 2831, 2832, 2618, 2623, 2624, 2625, 2627, 2628, 2629 and turns eastward covering the northern boundaries of C.S. Dag No. 2630, 2626, 2621, 2620, 2619, 2617, 2616 and continues north cross the road and part of 2562 then turn east covering the northern boundary of C.S. Dag No. 2840 and meets the starting point.

WARD NO. 3

Starting from southeast corner of C.S. Dag No. 2798, adjacent to N.H. 02 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes towards west covering the southern boundaries of C.S. Dag Nos. 2797, 2780, 2779 and turn north covering the western boundaries of C.S. Dag Nos. 2780, 2779, and turn west covering the southern boundaries of C.S. Dag Nos. 2738, 2737, 2736, 2735, 2732, 2729, 2728, 24727, 2714, 2715, 2716 and cross the road and meets the southeastern corner of C.S. Dag No. 2697 then turn north covering the southern boundaries of C.S. Dag Nos. 2696, 2695, 2694, 2693, 2692. The line goes towards east covering the northern boundaries of C.S. Dag No. 2691, 2720, 2721, 2722, 2723, 2726, 2819, 2821, 2822, 2823, 2824 and meets the N.H. 02 and then turn south covering the eastern boundaries of C.S. Dag No. 2804, 2803, 2799, meets the starting point.

WARD NO. 4

Starting from the northeast corner of C.S. Dag No. 2795, adjacent to N.H. 02 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes south covering the eastern boundaries of C.S. Dag Nos. 2794, 2791.

The line moves towards Village No. 29 Maharabi, Sheet No.1, along the road covering C.S. Dag No. 1 and goes west covering southern boundaries of C.S. Dag No. 1.

Further, the line moves west towards Village No. 30 Sekmai, Sheet No. 7, covering the southern boundaries of C.S. Dag Nos. 3592, 3590, 3589, 3582, 3581, 3580, 3579.

The line again continues north, towards the Village No. 30 Sekmai, Sheet No. 6, along the road covering the western boundaries C.S. Dag Nos. 2753, 2757, 2754, 2755, 2754, 2753, 2752, 2700, 2699, 2698 and turn east covering the northern boundaries of C.S. Dag Nos. 2698, then cross the river and meets northwest corner of C.S. Dag No. 2710 and the line continues towards east covering the northern boundaries of C.S. Dag Nos.2712, 2710, 2709, 2708, 2740, 2776, 2777, 2778, 2775, 2784 and meets the starting point C.S. Dag No. 2795.

WARD NO. 5

Starting from the northeast corner of C.S. Dag No. 2677 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes south covering the eastern boundaries of C.S. Dag No. 2677, 2679 and turn west covering the southern boundaries of C.S. Dag No. 2681, 2682, 2683, 2684, 2685, 2688.

The line continues further west towards the Village No. 30 Sekmai, Sheet No. 5, covering C.S. Dag Nos. 2381 and turn north covering the western boundaries of C.S. Dag No. 2381, 2380, 2379, 2376, 2375, 2372, 2371, 2368, 2367, 2270.

The line again moves east towards Village No. 30 Sekmai, Sheet No. 6, covering the northern boundaries of C.S. Dag Nos. 2655, 2656, 2660, 2661, 2662, 2673, 2674, 2675, 2676, meets the starting point C.S. Dag No. 2677.

WARD NO. 6

Starting from northeast corner of C.S. Dag No. 2551 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes south covering the northern boundaries of C.S. Dag Nos. 2558, 2560, 2561, 2562 and goes south along the road covering C.S. Dag No. 2613 then continues west covering the southern boundaries of C.S. Dag Nos. 2631, 2632, 2633, 2634, 2635, 2636 and cross the road to meet at the southeast corner of C.S. Dag No. 2652 and the line further continues toward north covering the western boundaries of C.S. Dag Nos. 2653, 2644.

The line turns northward towards the Village No. 30 Sekmai, Sheet No. 5, covering the western boundaries of C.S. Dag Nos. 2351, 2350, 2349.

Then again moves towards Village No. 30, Sekmai, Sheet No. 6, the line goes north covering C.S. Dag Nos. 2592, 2591, 2586, 2582, 2583, 2584, 2555, meets the starting point.

WARD NO. 7

Starting from northeast corner of C.S. Dag No. 2512 of Village No. 30 Sekmai, Sheet No. 6, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag Nos. 2512, 2513, 2514, 2520, 2521, 2522, 2523, 2524, 2525, 2526 and goes southwest covering the southern boundaries of C.S. Dag No. 2527, 2523, 2521, 2550, 2549, 2547, 2546 and turn north covering the western boundaries of C.S. Dag No. 2546, 2545, 2540, 2536, 2534, 2533, 2531, 2517, 2516, 2510, 2509 and turn east covering the northern boundaries of C.S. Dag No. 2508, 2512 and meets the starting point.

WARD NO. 8

Starting from the northeast corner of C.S. Dag No. 2107 of Village No. 30, Sekmai, Sheet No. 5, the ward boundary line goes east covering the northern boundaries of C.S. Dag No. 2277, 2278, 2280, 2279, 2274, 2273, 2331, 2346 and goes south covering the eastern boundaries of

C.S. Dag No. 2353, 2352, 2362 then turn north along the road covering the western boundaries of C.S. Dag No. 2270, 2255, 2256, 2262, 2267, meets the starting point.

WARD NO. 9

Starting from the northeast corner of C.S. Dag No. 2313 of Village No. 30 Sekmai, Sheet No.5, the ward boundary line goes south along the road covering the eastern boundaries of C.S. Dag No. 2314, 2315, 2316, 2330, 2324, 2326, 2329 and turn west covering the southern boundaries of C.S. Dag No. 2327, 2411, 2308, 2283, 2282, 2284, and goes upward along the river covering the western boundaries of C.S. Dag No. 2270 (part of) and continues east covering the northern boundaries of C.S. Dag No. 2301, 2302, meets the starting [point.
