Imphal, the 3rd November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/22: Whereas, Town Planning Department, Manipur in collaboration with the Wangoi Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Wangoi Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Wangoi Municipal Council in its meeting held on 21.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Wangoi Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Imphal West in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED WANGOI MUNICIPAL AREA

Part A:

Starting from the northwest corner of C.S. Dag No. 74 of Oinam Saombung Village No. 88, (Ward No. 4), the boundary line goes east covering northern boundaries of C.S. Dag No. 74, 72, 71, 67 and goes south along the river covering C.S. Dag No. 81, 82, 102, 105, 108, 160, 161, 162, 163, 181, 182, 179, 335, 177, 176.

The line continues towards Wangoi Village No. 87, Sheet No. 1, along the road covering C.S. Dag No. 544, 543, 549, 555, 577, 573.

Then moves towards Thiyam Leishangkhang Village No. 86, covering C.S. Dag No. 3, 2, 33, 48, 49.

Further the line continues south towards Wangoi Top Village No. 85, Sheet No. 1, along the Mayai Lambi covering C.S. Dag No. 33, 300, 299 and turn west covering C.S. Dag No. 48, 53, 32, 56, 57, 42, 41, 20.

The line then moves towards Wangoi Village No. 87, Sheet No. 2, covering C.S. Dag No. 1329, 1328, 1327, 1252, 1402, 1151, 1246, 1238, 1237, 1235, 1410, 1203, 1209, 1207, 1132, 1131, 1130, 1129, 1072, 1068, 1064, 1063, 1062, 1061, 1060, 1057, 1054, 1055 and turn north covering C.S. Dag No. 1050, 1025, 1024 and goes east covering C.S. Dag No. 1021, 1022, 1152, 1153, 1154, 1191, 1190, 1189, 1266, 1230 and turn towards north covering C.S. Dag No. 1300, 1308, 1307, 1305, 1276, 1277, 1278, 1284, 1283.

The line continues towards Wangoi Village No. 87, Sheet No. 1, covering western boundaries of C.S. Dag No. 414, 418, 420, 421, 422, 423, 424, 425, 427, 428, 432, 435, 436, 437, 438, 385, 384, 381, 380, 376, 369, 368, 357, 358, 359, 279, 278, 277, 270, 269, 252, 580, 579, 228, 227, 226, 225, 220 and turn east covering northern boundaries of C.S. Dag No. 220, 221, 222, 235 and goes south along the Mayai Lambi covering C.S. Dag No. 236, 237, 238 cross the road and meets the starting point.

Part B:

Starting from the northwest corner of C.S. Dag No.3 of Laiphrakpam Village No. 83, (Ward No. 7) , adjacent to the river, the boundary line goes towards east along the river covering C.S. Dag No. 2, 35, 78 and goes south along the river covering C.S. Dag No. 79, 90, 91, 139, 94, 99, 100, 134, 135, 101, 92, 103, 153, 152, 151, 150, 105, 144, 143, 109, 142, 141, 114, 115, 117, 118, 119, 126, 128.

The line moves east towards Bitraurokhok Village No. 82, along the river covering C.S. Dag No. 517, 1, 11, 14, 16, 536, 63, 64, 65 and goes south along the road covering C.S. Dag No. 75, 66, 67, 68, 73, 74, 76, 77, 78, 79, 80, 81, 82, 83 and turn north covering western boundaries of C.S. Dag No.83, 82, 81 and goes towards west covering C.S. Dag No. 53, 23, 22, 20.

The line then moves towards Lakuhuidrom Village No. 84, Sheet No. 1, covering C.S. Dag No. 566, 568, 564, 591.

Then continues west again towards Bitraurokhok Village No. 82, covering C.S. Dag No. 8, 7, 6, 5.

Then moves north towards Laiphrakpam Village No. 83, Sheet No. 1, covering C.S. Dag No. 132, 121, 120, 119, 118, 149, 113, 111, 107, 106, 56, 54, 53, 50, 25, 24, 23, 22, 21.

Further, the line continues west towards Lakuhuidrom Village No. 84, Sheet No. 1, covering C.S. Dag No. 21, 20, 19, 15, 14, 9, 8.

The line continues towards Laiphrakpam Village No. 83, Sheet No. 1, covering C.S. Dag No. 172, 136, meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED WANGOI MUNICIPAL AREA

WARD NO. 1

Starting from the northeast corner of C.S. Dag No. 1253 of Wangoi Village No. 87, Sheet No. 2, the ward boundary line goes south covering C.S. Dag No. 1252, 1402, 1151 and goes west covering C.S. Dag No. 1246, 1238, 1237, 1235, 1410, 1203, 1209, 1207, 1132, 1131, 1130, 1129, 1072, 1068, 1064, 1063, 1062, 1061, 1060, 1057, 1054, 1055 and turn north covering C.S. Dag No. 1050, 1025, 1024 and goes east covering C.S. Dag No. 1021, 1022, 1152, 1153, 1154, 1191 and continues south covering eastern boundaries of C.S. Dag No. 1191, 1192 and goes east covering C.S. Dag No. 1197, 1257, meets the starting point.

WARD NO. 2

Starting from the northeast corner of C.S. Dag No. 1293 of Village Wangoi No. 87, Sheet No. 2, the ward boundary line goes south covering C.S. Dag No. 1294, 1295, 1296, 1297, 1298, 1299, 1300, 1316, 1315, 1314, 1313, 1319, 1320, 1321, 1323, 1261 and goes west covering C.S. Dag No. 1253, 1196 and continues towards north covering C.S. Dag No. 1195, 1193, 1190. The line then continues east covering C.S. Dag No. 1190, 1189, 1266, 1230 and turn towards north covering C.S. Dag No. 1300, 1308, 1307, 1305, 1276, 1277, 1278, 1284, 1283 and turn east covering C.S. Dag No. 1285, 1286, 1237, 1288, 1289, meets the starting point.

WARD NO. 3

Starting from the northeast corner of C.S. Dag No. 235 of Wangoi Village No. 87, Sheet No. 1, adjacent to the Mayai Lambi, the ward boundary line goes south along the road covering C.S. Dag No. 236, 237, 238, 239, 241, 243, 247, 248, 273, 274, 275, 363, 364, 372, 382, 383, 441, 442, 440, 439, 443, 444, 445, 448 and turn east covering C.S. Dag No. 193, 192, then turn south covering C.S. Dag No. 195, 198, 523, 522, 521, 520 and goes west covering C.S. Dag No. 518 cross the Mayai Lambi and goes west covering C.S. Dag No. 505, 504, 503, 487, 486, 484, 478, 476, 415, 414 and continues north covering C.S. Dag No. 414, 418, 420, 421, 422, 423, 424, 425, 427, 428, 432, 435, 436, 437, 438, 385, 384, 381, 380, 376, 369, 368, 357, 358, 359, 279, 278, 277, 270, 269, 252, 580, 579, 228, 227, 226, 225, 220 and turn east covering northern boundaries of C.S. Dag No. 220, 221, 222, 235, meets the starting point.

WARD NO. 4

Starting from the northwest corner of C.S. Dag No. 74 of Oinam Saombung Village No. 88, the boundary line goes east covering northern boundaries of C.S. Dag No. 74, 72, 71, 67 and goes south along the river covering C.S. Dag No. 81, 82, 102, 105, 108, 160, 161, 162, 163, 181, 182, 179, 335, 177, 176.

The line continues towards Wangoi Village No. 87, Sheet No. 1, along the road covering C.S. Dag No. 544 and turn west covering C.S. Dag No. 553, 526, 525 then continues north covering C.S. Dag No. 527, 528, 529, 530, 191, 190, 189, 187, 205, 185, 182, 132, 130, 129, 127, 123, 122, 94, 93, 92, 99, 88, 76, 74, meets the starting point.

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 570 of Wangoi Village No. 87, Sheet No. 1, adjacent to the Mayai Lambi, the ward boundary line goes towards east covering C.S. Dag No. 569, 564, 561, 559, 557, 556 and goes south along the road covering C.S. Dag No. 577, 573.

Then continues south towards Thiyam Leishangkhong Village No. 86, covering C.S. Dag No. 3, 2, part of 33, part of 35, 34 and turn north along the Mayai Lambi covering C.S. Dag No. 34 cross the road.

Further, the line continues west towards Wangoi Village No. 87, Sheet No. 2, covering C.S. Dag No. 1384, 1347, 1256 and turn north covering C.S. Dag No. 1256, 1360, 1412, 1401, 1361, 1366, 1368, 1369, 1370 cross the road and meets the starting point.

WARD NO. 6

Starting from the northwest corner of C.S. Dag No. 1354 of Wangoi Village No. 87, Sheet No. 1, the ward boundary line goes east covering C.S. Dag No. 1347, 1345, 1344, 1310, 1319, 1388, 1387, 1386 and meets the Mayai Lambi.

The line continues east towards Thiyam Leishangkhong Village No. 86, covering C.S. Dag No. part of 35, 36, part of 33 and turn south covering C.S. Dag No. 48 and turn west covering southern boundaries of C.S. Dag No. 48, 49.

Further, the line continues towards Wangoi Top Village No. 85, Sheet No. 1, along the Mayai Lambi covering C.S. Dag No. 33, 300, 299 and turn west covering C.S. Dag No. 48, 53, 32, 56, 57, 42, 41, 20.

The line then moves towards Wangoi Village No. 87, Sheet No. 2, covering C.S. Dag No. 1406, 1330, 1329, 1328 and turn north along the road covering eastern boundaries of C.S. Dag No. 1328, 1329, 1406, 1405, 1331, 1332, 1333, 1334, 1335, 1336, 1337, 1352, meets the starting point.

WARD NO. 7

Starting from the northwest corner of C.S. Dag No.3 of Laiphrakpam Village No. 83, adjacent to the road, the ward boundary line goes towards east along the river covering C.S. Dag No. 3, 171, 4, 167, 170, 169, 7, 13, 14, 175, 34, 37, 64, 82, 81, 80 and turn south covering C.S. Dag No. 80, 84 then goes west covering C.S. Dag No. 83, 69, 68, 176, 40, 41, 42, 44, 29, 30, 22, 21.

The line continues towards Laiphrakpam Village No. 83, Sheet No. 1, covering C.S. Dag No. 172, 136 and 3, meets the starting point.

WARD NO. 8

WARD NO. 9

The line then moves towards Lakuhuidrom Village No. 84, Sheet No. 1, covering C.S. Dag No. 566, 568, 564, 591.

Then continues west again towards Bitraurokhok Village No. 82, covering C.S. Dag No. 8, 7, 6, 5 and turn north covering C.S. Dag No. 5, 6, 7, 3, 2, 1, meets the starting point.
