# NOTIFICATION

Imphal, the 3<sup>rd</sup> November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/4: Whereas, Town Planning Department, Manipur in collaboration with the Kakching Khunou Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Kakching Khunou Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Kakching Khunou Municipal Council in its meeting held on 20.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Kakching Khunou Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Kakching in writing within 45 days from the date of publication of this Notification.

#### RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED KAKCHING KHUNOU MUNICIPAL AREA

Starting from the northeast corner of C.S. Dag No. 1055(Ward No. 1) of Thongam Village No. 82, Sheet No. 3, the boundary line goes east along the road covering northern boundaries of C.S. Dag Nos. 1128, 1129, 1139 and 1157.

The line continues north towards Kakching Khunou, Village No. 80, 81, covering the western boundaries of C.S. Dag Nos. 523, 521 and goes southward covering the eastern boundaries of C.S. Dag Nos. 528 and 524 then turning towards east along the road covering the northern boundaries of C.S. Dag Nos. 211, 610, part of 611, 612, 169, 654, 652, 651, 645, 641, 640, 638, 637, 636, 635, 634, 632, and crosses the Burma-Sugnu Road 1070, 1071, 1072. Further the line goes west covering the southern boundaries of C.S. Dag Nos. 1074, 1075, 1076, 1077, 1078 and crosses Burma-Sugnu Road, 1080, 665, 661, 659, 672, 193, 194 and 1970f same village.

Further the line goes west toward Kakching Khunou Village No. 80, Sheet No. 4, covering the southern boundaries of C.S. Dag No.1427 and continues toward southward covering the eastern boundaries of C.S. Dag Nos. 1342, 1386, 1391, 1392, 1384, 1365, 1364, 1399, 1401, 1311, 1312, 1339, 1292, 1297, part of 1299 then goes east covering the northern boundaries of C.S. Dag Nos. 1301, 1405, 1342, 1408, 1409, 1453, 1454, 1506, 1504, 1458, 1457, 1489, 1491 and goes towards south covering the eastern boundaries of C.S. Dag No. 1490 of same village.

The line continues south towards Kakching Khunou 1<sup>st</sup> Part Village No. 80, Sheet No. 5 covering the eastern boundaries of C.S. Dag Nos. 2134, 2135, 2141, 2142, 2143, 2144, 2145, 2146, 2147, 2148, 2149, 2150, 2151, 2152, 2165, 2166, 2168 and continues towards west covering the southern boundaries of C.S. Dag No. 2168 and crosses the Burma-Sugnu Road. The line continues same direction covering the southern boundaries of C.S. Dag Nos. 2127, 2008, 2215, 2214, 2007 of same village.

The line then goes north towards Kakching Khunou Village No. 80, Sheet No. 4, covering the western boundaries of C.S. Dag Nos. 1187, 1188, 1192, 1194, 1197, 1198, 1199, 1200, 1201, 1165, 1150, 1149, 1072, 1069, 1016, 1017, 1018, 1019, 1020, 1021, 1022, 1023, 1024, 1025, 1026, 1027, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1037, 1038, 1039, 1040, 1041, 1042 and 1110.

The line continues west towards Thongam, Village No. 82, Sheet No. 3, covering the southern boundaries of C.S. Dag No. 1096 along the road and turns northward covering the eastern boundaries of C.S. Dag Nos. 1100, 1094, 1093, 1094, 1091, 1090, 1089, 1088, 1087, 1086, 1085, 1084, 1083, 1082, 1081, 1080, 1079, 1078, 1077, 1076, 1075, 1211, 1074, 1070, 1044, 1045, 1052, 1051, 1054, 1029 and meeting the starting point.

# BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED KAKCHING KHUNOU MUNICIPAL AREA WARD NO. 1

Starting from north eastern corner of C.S. Dag No. 1055 of Thongam Village No. 82, Sheet No. 3, the ward boundary line goes east along the road covering the northern boundaries of C.S. Dag Nos. 1127, 1128, 1129, the line crosses the road and goes towards south covering the eastern boundaries of C.S. Dag Nos. 1058, 1059, 1206, 1123, 1122, 1164, 1165, 1169, 1171, 1172, 1185, and continues south along the road covering the eastern boundaries of C.S. Dag Nos. 1186, 1194, 1096 and continues towards north covering the western boundaries of C.S. Dag Nos. 1100, 1094, 1093, 1092, 1091, 1090, 1089, 1088, 1087, 1086, 1085, 1084, 1083, 1082, 1081, 1080, 1079, 1078, 1077, 1076, 1075, 1211, 1074, 1070, 1044, 1045, 1052, 1051, 1054, 1029 and meeting the starting point.

# WARD NO. 2

Starting from the northwestern corner of C.S. Dag No. 523 of Kakching Khunou Village No. 81, Sheet No. 1, the ward boundary line goes towards east covering the northern boundaries of 528, 521 and goes south covering the eastern side of C.S. Dag No. 528 and turns towards west covering the southern boundaries of C.S. Dag No. 528, 523 and 524.

The line crossing the road and continues south towards Thongam Village No. 82, Sheet No. 3, covering C.S. Dag No. 1161, along the road and continues the south towards Village No. 80, 81, Kakching Khunou, covering C.S. Dag No. 51, then turns towards west covering the southern boundaries of C.S. Dag Nos. 50, 49, 29, 12, 11, 10 and continues towards north covering the western boundaries of C.S. Dag Nos. 9, 8, 7, 6, 5, 4, 3, 2, 1, 27 and 28 of same village.

Further the line continues north towards Thongam Village No. 82, Sheet No. 3, covering the western boundaries of C.S. Dag No. 1170, 1218, 1168, 1167, 1166, 1163, 1162, 1124, and crossing the road and touch the northwestern corner of C.S. Dag No.1157 and meets the starting point.

# WARD NO. 3

Starting from the northeastern corner of C.S. Dag No. 70 of Kakching Khunou Village No. 81, Sheet No. 1, the ward boundary line goes towards north covering the western boundary of C.S. Dag No. 71 and goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 169 and 211. Then the line continues southward along the road covering the eastern boundaries of C.S. Dag No. 109 and goes westward covering the southern boundaries of C.S. Dag Nos. 90, 89, 88, 72, 182 and 52. The line turns towards north covering the western boundaries of C.S. Dag Nos. 53, 54, 55, 56, 57, 218, 58, 59, 60, 61, 62, 63, 64, 65, 66 of same village.

The line then continues north towards Thongam Village No. 82, Sheet No. 3, covering the western boundaries of C.S. Dag Nos. 1215 and crossing the road.

The line continues towards Kakching Khunou 2<sup>nd</sup>part Village No. 81, Sheet No. 2, covering northern boundaries of C.S. Dag Nos. 523, 521 and turns south covering the eastern and southern boundaries of C.S. Dag Nos. 528, 523, 524 then continues south to meets the C.S. Dag No. 108 and meets the starting point.

#### WARD NO. 4

Starting from northeastern corner of C.S. Dag No. 111 of Kakching Khunou Village No. 81, Sheet No. 1, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 211, 610, part of 611, 612, 169, 654, 652, 651, 645, 641, 640, 638, 637, 636, 635, 634, 632, and crosses the Burma-Sugnu Road 1070, 1071, 1072. Further the line goes west covering the southern boundaries of C.S. Dag Nos. 1074, 1075, 1076, 1077, 1078 and crosses Burma-Sugnu Road, 1080, 665, 661, 659, 672, 193, 194, 197, 186, 187, 176, 175, 178, 179, 180, 181, 182, 123 and continues towards along the road covering the western boundaries of C.S. Dag No. 123, 122, 121, 213, 120, 212, 199, 118, 117, 116, 115, 114, 113, 112 and meets the starting point.

#### WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 1340 of Kakching Khunou Village No. 80, Sheet No. 4, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 1342, 1427, 1386 and goes west covering southern boundaries of C.S. Dag Nos. 1391, 1392. The line then goes southward covering the eastern boundaries of C.S. Dag Nos. 1384, 1365, 1364, 1399, 1401, 1311 and turn towards west covering the southern boundaries of C.S. Dag No. 1312. Further the line continues towards north along the road covering the western boundaries of C.S. Dag Nos. 1313, 1314, 1315, 1316, 1317, 1318, 1319, 1320, 1321, 1322, 1323, 1324, 1325, 1326, 1327, 1328, 1329, 1330, 1331, 1332, 1333, 1334, 1335, 1336, 1337, 1338, 1341 and meets the starting point.

# WARD NO. 6

Starting from the north eastern corner of C.S. Dag No. 1257 of Kakching Khunou Village No. 80, Sheet No. 4, the ward boundary line goes towards south along the road covering the eastern boundaries of C.S. Dag Nos. 1339, 1292, 1294, 1296, 1297 and continues towards west along the road covering the southern boundaries of C.S. Dag Nos. 1256, 1217 and again tuns towards north along the road covering the western boundaries of C.S. Dag Nos. 1218, 1219, 1220, 1221, 1222, 1223, 1224, 1225, 1226, 1227, 1502, 1229, 1230, 1231, 1232, 1233, 1234, 1235, 1236, 1237, 1238, 1239, 1240, 1241, 1242, 1550, 1243, 1244, 1245, 1246, 1247, 1248, 1250, 1251, 1252, 1253, 1254, 1255 and meets the road then turns towards east and meeting the starting point.

#### WARD NO. 7

Starting from the northeastern corner of C.S. Dag No. 1111 of Kakching Khunou Village No. 80, Sheet No. 4, the ward boundary line goes towards south along the road covering the eastern boundaries of C.S. Dag Nos. 1249, 1228, then turns west along the road covering C.S. Dag No. 1147, 1148, 1073 and continues towards north covering the eastern boundaries of C.S. Dag Nos. 1074, 1075, 1076, 1077, 1078, 1079, 1080, 1082, 1083, 1084, 1085, 1086, 1087, 1088, 1499, 1089, 1090, 1091, 1092, 1093, 1094, 1095, 1096, 1097, 1098, 1099, 1100, 1101, 1102, 1103, 1104, 1105, 1106, 1107, 1109 and meets the road then turns towards east and meeting the starting point.

# WARD NO. 8

Starting from the northwestern corner of C.S. Dag No. 1042 of Kakching Khunou Village No. 80, Sheet No. 4, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag No. 1100 and touch the north eastern corner of C.S. Dag No. 1044, then turns towards south along the road covering the eastern boundaries of C.S. Dag Nos. 1108, 1081, 1072. Further, the line goes east along the road covering the northern boundaries of C.S. Dag Nos. 1148, 1149, 1216 and parts of 1297, 1299, 1300, 1188, then turns towards west covering the southern boundaries of C.S. Dag Nos. 1192, 1192, 1194, 1197, 1198, 1199, 1200, 1201, 1165, 1150 and continues towards north covering the eastern boundaries of C.S. Dag Nos. 1150, 1149, 1072, 1069, 1016, 1017, 1018, 1019, 1020, 1021, 1022, 1023, 1024, 1025, 1026, 1027, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1037, 1038, 1039, 1040, 1041 and meeting the starting point.

# WARD NO. 9

Starting from the northwestern corner of C.S. Dag No. 1405 of Kakching Khunou Village No. 80, Sheet No. 4, the ward boundary line goes towards east covering the norther boundaries of C.S. Dag Nos. 1342, 1408, 1409, 1453, 1454, 1506, 1504, 1458, 1457, 1489, 1491 and goes towards south covering the eastern boundaries of C.S. Dag No. 1490.

The line continues south towards Kakching Khunou 1<sup>st</sup> part Village No. 80, Sheet No. 5, covering the eastern boundaries of C.S. Dag Nos. 2134, 2135, 2141, 2142, 2143, 2144, 2145, 2146, 2147, 2148, 2149, 2150, 2151, 2152, 2165, 2166, 2168 and continues towards west covering the southern boundaries of C.S. Dag No. 2168 and crosses the Burma-Sugnu Road. The line continues same direction covering the southern boundaries C.S. Dag Nos. 2127, 2008, 2215, 2214, 2007.

The line then goes north towards Kakching Khunou Village No. 80, Sheet No. 4, covering the western boundaries of C.S. Dag No. 1187, 1301 and meeting the starting point.
