Imphal, the 3rd November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/5: Whereas, Town Planning Department, Manipur in collaboration with the Kumbi Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Kumbi Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Kumbi Municipal Council in its meeting held on 30.10.2024 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Kumbi Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Bishnupur in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED KUMBI MUNICIPAL AREA

Starting from the northwest corner of C.S. Dag No. 2373 (Ward No.9) of Kumbi Village No. 64, Sheet No. 3 the boundary line goes towards east covering the northern boundaries of C.S. Dag Nos. 2373, 2374, 2375, 2382, 2381, 2408.

The line continues east towards Sheet No. 6 of Kumbi Village No. 64, covering northern boundaries of C.S. Dag Nos. 5180, 5181, 5188, 5183, 5184, 5185.

The line then continues north towards Village No. 64 Kumbi, Sheet No. 2, covering western boundaries of C.S. Dag Nos. 1114, 1113, 1112, 1111, 1110, 1109, 1108, 1107, 1106, 1105 and goes towards east covering northern boundaries of C.S. Dag Nos. 1105, 1123, 1122, 1121, 1128, 1129, 1130, 1131.

Further, the line continues towards Village No. 64 Kumbi, Sheet No. 6, covering northern boundaries of C.S. Dag Nos. 5337, 5457, 5458 and continues south covering eastern boundaries of C.S. Dag Nos. 5459, 5460, 5461, 5462, 5463, 5465, 5466 then continues east covering northern boundaries of C.S. Dag No. 5478 of the same village.

The line then continues towards Village No. 64 Kumbi, Sheet No. 7 covering the northern boundaries of C.S. Dag Nos. 6253, 6001, 6021, 6022, 6028, 6029, 6034, 6035, 6041, 6042 and continues south along the river until it reaches southeast corner of C.S. Dag No. 6044. The line crosses the river and meets the northwest corner of C.S. Dag No. 6076 and moves along the eastern boundaries of C.S. Dag Nos. 6078 (Pt) and 6079 (Pt). The line continues west covering the southern boundaries of C.S. Dag Nos. 6079, 6088, 6089, 6095, 6096, 6098, 6100. The line turns towards south covering the eastern boundaries of C.S. Dag Nos. 6100, 6101, 6110, 6111, 6149, 6147, 6155, 6162, 6163, 6166, 6167.

The line moves towards Sheet No. 6 of Village No. 64 Kumbi, covering the southern boundaries of C.S. Dag Nos. 5787, 5786, 5785.

The boundary line continues west towards Sheet No. 9 of Village No. 64 Kumbi covering the southern boundaries of C.S. Dag Nos. 8035, 8038, 44, 39, 8031.

The line then moves west towards Sheet No. 6 of Village No. 64 Kumbi covering the southern boundaries of C.S. Dag Nos. 5822, 5723, 5820, 5720, 5719.

Further, the line moves towards Village No. 62 Wangu Keirap, covering the southern boundaries of C.S. Dag No. 1006 and parts of 1036.

The line continues towards Village No. 62 Wangu Keirap, Sheet No. 1, covering the eastern boundaries of C.S. Dag No. 7 and goes towards north along the road.

The line moves towards Village No. 64 Kumbi, Sheet No. 9, covering the western boundaries of C.S. Dag Nos. 8007, 8011, 8010, 8016, 8020, 8019, 8021, 8022.

The line continues towards Village No. 62, Wangu Keirap, along the road covering C.S. Dag Nos. 1001, 1002, 1000, 1005.

The line then continues west towards Village No. 64 Kumbi, Sheet No. 6, along the foothill covering C.S. Dag Nos. 5715, 5714, 5712, 5711, 5710, 5709, 5708, 5707, 5706, 5705, 5704, 5703, 5702, 5651, 5650, 5649, 5648, 5647, 5646, 5645, 5641 and move towards north covering the western boundaries of C.S. Dag Nos. 5641, 5640, 5639, 5638, 5637, 5636, 5635, 5634, 5633, 5632, 5630, 5629, 5628, 5840, then turn west covering the southern boundaries of C.S. Dag Nos. 5602, 5601, 5600, 5599, 5597, 5596, 5595, 5594, 5590, 5589 and again turn towards north covering the western boundaries of C.S. Dag Nos. 5588, 5587. The line then goes north along the river bank covering the western boundaries of C.S. Dag Nos. 5095, 5091, 5073, 5074, 5075, 5076, 5080, 5079, 5078, 5067, 5063, 5065 of same village.

The line continues towards Sheet No. 3, Village No. 64 Kumbi, covering the western boundaries of C.S. Dag Nos. 2170, 2169, 2168, 2111, 2112 and continues towards east covering the northern boundaries of C.S. Dag Nos. 2165, 2182, 2404, 2191, 2190. The line crosses the road and goes slightly north and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED KUMBI MUNICIPAL AREA

WARD NO. 1

Starting from the northeast corner of C.S. Dag No. 2190 of Village No. 64 Kumbi, Sheet No. 3, the ward boundary line goes south along the road covering the eastern boundaries of C.S. Dag No. 2200, 2199.

The line moves south towards Sheet No. 6 of Village No. 64 Kumbi, along the road covering the eastern boundaries of C.S. Dag Nos. 5115, 5116, 5118, 5908, 5119, 5120 and meets the river then goes southwest along the river covering the southern boundaries of C.S. Dag Nos. parts of 5108, 5102, 5097, 5096, 5095 and continues north covering the western boundaries of C.S. Dag Nos. 5095, 5091, 5073, 5074, 5075, 5076, 5080, 5079, 5078, 5067, 5063, 5065 of same village.

The line continues towards Sheet No. 3 of Village No. 64 Kumbi, covering the western boundaries of C.S. Dag Nos. 2170, 2169, 2168, 2111, 2112 and continues towards east covering the northern boundaries of C.S. Dag Nos. 2165, 2182, 2404, 2191, 2190 and meets the starting point.

WARD NO. 2

Starting from the southeast corner of C.S. Dag No. 5785 adjacent to the road of Village No. 64 Kumbi, Sheet No. 6, the ward boundary line goes west covering the southern boundaries of C.S. Dag Nos. 5785, 5786.

The boundary line continues west towards Sheet No. 9 of Village No. 64 Kumbi, covering C.S. Dag Nos. 8035, 8038, 44, 39, 8031.

The line then moves west towards Sheet No. 6 of Village No. 64 Kumbi, covering the southern boundaries of C.S. Dag Nos. 5822, 5723, 5820, 5720, 5719.

Further, the line moves towards Village No. 62, Wangu Keirap, covering the southern boundaries of C.S. Dag Nos. 1006 and parts of 1036.

The line then continues towards Village No. 62 Wangu Keirap, Sheet No. 1, covering the eastern boundaries of C.S. Dag No. 7 and goes towards north along the road and moves towards Village No. 64 Kumbi, Sheet No. 9, covering the western boundaries of C.S. Dag Nos. 8007, 8011, 8010, 8016, 8020, 8019, 8021, 8022.

The line continues towards Village No. 62, Wangu Keirap, along the road covering the northern boundaries of C.S. Dag Nos. 1001, 1002, 1000, 1005.

The line then continues west towards Village No. 64 Kumbi, Sheet No. 6, along the foothill covering the southern boundaries of C.S. Dag Nos. 5715, 5714, 5713, 5712, 5711, 5710, 5709, 5708, 5707, 5706, 5705, 5704, 5703, 5702, 5651, 5650, 5649, 5648, 5647, 5646, 5645, 5641 and move towards north covering the western boundaries C.S. Dag Nos. 5641, 5640, 5639, 5638, 5637, 5636, 5635, 5634, 5633, 5632, 5630, 5629, 5628, 5840. The line turns west covering the southern boundaries of C.S. Dag Nos. 5602, 5601, 5600, 5599, 5597, 5596, 5595, 5594, 5590, 5589 and goes towards north covering the western boundaries of C.S. Dag Nos. 5588, 5587 goes north along the river including C.S. Dag Nos. 5581, 5582, 5579, 5578, 5817, 5576, 575, 5574, 5573, 5572, 5571, 5570, 5569, 5568, 5892, 5567 and goes towards east along the river covering the northern boundaries of C.S. Dag Nos. 5566, 5565, 5839, 5816, 5564, 5563, 5561, 5556, 5553 then continues south covering the eastern boundaries of C.S. Dag Nos. 5552, 5551, 5550, 5549, 5548, 5547, 5546, 5614, parts of 5676, 5682, 5681, 5680, 5688, 5689, 5690, 5691, 5884, 5756, 5752, 5785 and meets the starting point.

WARD NO. 3

Starting from the northwest corner of C.S. Dag No. 6075, adjacent to the river of Village No. 64 Kumbi, Sheet No. 7, the ward boundary line goes south covering the eastern boundaries of C.S. Dag Nos. 6076, 6078 (Pt), 6079 (Pt) then continues west covering the southern boundaries of C.S. Dag Nos. 6079, 6088, 6089, 6095, 6096, 6098, 6100 and turn towards south covering the eastern boundaries of C.S. Dag Nos. 6100, 6101, 6110, 6111, 6149, 6147, 6155, 6162, 6163, 6166 and 6167.

The line then moves north towards Sheet No. 6 of Village No. 64 Kumbi, covering the western boundaries of C.S. Dag Nos. 5787, 5780, 5757 and turn west covering the southern boundaries of C.S. Dag No. 5757. The line goes north covering the western boundaries of C.S. Dag Nos. 5777, 5760, 5762 and crosses the road towards west covering the southern boundaries of C.S. Dag Nos. 5679, 5678, 5677, parts of 5676, 5544, 5807, 5806, 5805, 5543, 5542, 5541, 5540, 5539 and turn east along the river covering the northern boundaries of C.S. Dag Nos. 5539, 5534, 536, 5895, 5819, 5527, 5525, 5521, 5519, 5516.

Further, the line continues east towards Village No. 64, Kumbi, Sheet No. 7, along the river covering the northern boundaries of C.S. Dag Nos. 6055, 6054, 6053, 6052, 6051, 6198, 6200, 6068, 6069 and meets the starting point.

WARD NO. 4

Starting from the southeast corner of C.S. Dag No. 6038 of Village No. 64 Kumbi, Sheet No. 7, the ward boundary line goes west along the road and river covering the C.S. Dag Nos. 6046, 6048.

The line then moves towards Sheet No. 6 of Village No. 64 Kumbi, along the road covering the eastern boundaries of C.S. Dag Nos. 5835, 5513 and turns west covering the southern boundaries of C.S. Dag Nos. 5513, 5503, 5499 then goes north covering the western boundaries of C.S. Dag Nos. 5498, 5497, 5496, 5495, 5493, 5491, 5490, 5489, 5474, 5473, 5472, until it reaches the southwest corner of C.S. Dag Nos. 5468 and turn east covering the southern boundaries of C.S. Dag Nos. 5468 then continues north covering C.S. Dag No. 5478.

The line then continues towards Sheet No. 7 of Kumbi Village No. 64, covering the northern boundaries of C.S. Dag No. 6253, 6001, 6021, 6022, 6028, 6029, 6034, 6035, 6041, 6042 and goes south covering the eastern boundaries of C.S. Dag No. 6041, 6040, 6039, 6203, 6038 and meets the starting point.

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 5337 of Kumbi Village No. 64, Sheet No. 6, the ward boundary line goes east covering the southern boundaries of C.S. Dag Nos. 5337, 5457, 5458 and continues south covering the eastern boundaries of C.S. Dag Nos. 5459, 5460, 5461, 5462, 5463, 5465, 5466, 5467, 5468, 5451, 5882, 5883, 5446, 5445, 5444, 5443, 5442, 5441, 5447, 5796, 5439, 5438, 5811, 5437, 5436, 5499, 5435, 5434, 5795, 5433. The line continue west along the river covering the southern boundaries of C.S. Dag Nos. 431, 879, 430, 914, 878, 877, 876, 875, then continues north and meets the southeastern corner of C.S. Dag No. 303 and goes north along the road covering the western boundaries of C.S. Dag Nos. 5377, 5376, 5375, 5792, 5793, 5374, 5373, 5372, 5799, 5798, 5368, 5367, 5797, 5363, 5362, 5361, 5360, 5359, 5358, 5357, 5356, 5355, 5354, 5353, 5352, 5351, 5350, 5349, 5348, 5347, 5346, 5345, 5344, 5343, 5342, 5341, 5340, 5339, 5338, 5337 and meets the starting point.

WARD NO. 6

Starting from the northwest corner of C.S. Dag No. 1123 of Kumbi Village No. 64, Sheet No. 2, the ward boundary line goes east and then south of C.S. Dag No. 1123, 1122, 1128, 1129, 1130, 1131, 1132.

The line moves towards Sheet No. 6 of Kumbi, Village No. 64, covering the eastern boundaries of C.S. Dag Nos. 332, 331, 330, 5329, 5328, 5327, 5326, 5325, 5324, 5323, 5322, 5321, 5320, 5319, 5317, 5313, 5312, 5311, 5310, 5309, 5308, 5307, 5306, 5305, 5304, 5303, 5302, 303 then continues west of same Dag No. and goes north along the road until reaches the southwest corner of C.S. Dag No. 5276, covering the western boundaries of C.S. Dag Nos. 5275, 5274, 5272, 5271, 5270, 5269, 5268, 5267, 5266, 5265, 5264, 5262, 5261, 5260, 5259, 5258, 5257.

The line then continues north towards Sheet No. 2 of Kumbi, Village No. 64, covering the western boundaries of C.S. Dag Nos. 1116, 1117, 1118, 1119, 1120, 1121, 1122, meeting the starting point.

WARD NO. 7

Starting from northeast corner of C.S. Dag No. 1105 of Kumbi Village No. 64, Sheet No. 2, the ward boundary line goes south along the road until reaches the southeast corner of C.S. Dag No. 1115.

The line continues towards Sheet No. 6 of Kumbi Village No. 64, covering the eastern boundaries of C.S. Dag Nos. 5256, 5255, 5254, 5243, 5252, 5250, 5249, 5248, 5278, 5279, 5280, 5281, 5299, 5297, 5296, 5295, 5790, 5293, 5292, 5874 and continues west along the river covering the southern boundaries of C.S. Dag No. 5874, 5291, 5297, 5289 then continues towards north along the road covering the western boundaries of C.S. Dag Nos. 5286, 5285, 5284, 5282, 5281, 5280, 5279, 5278, 5245, 5244, 5243, 5242, 5241, 5240, 5239, 5238, 5236.

The line then continues towards Sheet No. 2 of Kumbi Village No. 64, covering the western boundaries of C.S. Dag Nos. 1114, 1113, 1112, 1111, 1110, 1109, 1108, 1107, 1106, meeting the starting point.

WARD NO. 8

Starting from northwest corner of C.S. Dag No. 5182 of Kumbi Village No. 64, Sheet No. 6, the ward boundary line goes east covering the southern boundaries of C.S. Dag Nos. 5183, 5184, 5185 and goes south along the road covering the eastern boundaries of C.S. Dag Nos. 5186, 5903, 5902, 5901, 5235, 5232, 5230, 5229, 5228, 5227, 5203, 5204, 5205, 5206, 5207, 5208, 5209, 5225, 5224, 5223, 5222, 5221, 5287. The line crosses the road and meets the river then goes west covering southern boundaries of part of C.S. Dag No. 5288 and move towards north covering the western boundaries of C.S. Dag Nos. 5166, 5849, 5167, 5168, 5169, 5170, 5171, 5172, 5173, 5174, 5175, 5176, 5177, 5178 and turn east and again turn towards north covering the western boundaries of C.S. Dag Nos. 5190, 5189, 5188 and meeting the starting point.

WARD NO. 9

Starting from northwest corner of C.S. Dag No. 2373, adjacent to Kumbi – Moirang Road of Village No. 64, Kumbi, Sheet No. 3, the boundary line goes east covering the northern boundaries of C.S. Dag Nos. 2373, 2374, 2375, 2382, 2381, 2408.

The line then continues east towards Sheet No. 6 of Kumbi Village No. 64, covering the northern boundaries of C.S. Dag Nos. 5180, 5181 and goes south covering the eastern boundaries of C.S. Dag Nos. 5181, 5179, 5156, 5157, 5158, 5159, 5160, 5788, 5789, 5161, 5162, 5163, 5134. The line crosses the road then turn west along the river covering the southern boundaries of C.S. Dag Nos. part of 5288, 633, 5132, parts of 5108 and meets the southwestern corner of C.S. Dag No. 5121 then moves towards north covering the western boundaries of C.S.

Dag Nos. 5121, 5122, 5123, 5124 then crosses the road and meets northeast corner of C.S. Dag No. 5127.

The line continues north towards Village No. 64, Kumbi, Sheet No. 3, along the road covering C.S. Dag Nos. 2201, 2205 meeting the starting point.
