# NOTIFICATION

Imphal, the 3<sup>rd</sup> November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/19: Whereas, Town Planning Department, Manipur in collaboration with the Sugnu Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Sugnu Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the SugnuMunicipal Council in its meeting held on 20.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Sugnu Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Kakching in writing within 45 days from the date of publication of this Notification.

#### RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED SUGNU MUNICIPAL AREA

Starting from the northwest corner of C.S. Dag No. 1364 (Ward no. 9), adjacent to the Burma-Sugnu Road of Sugnu Village No. 91, Sheet No. 2, the boundary line goes east covering C.S. Dag No. 1364, 1385, 1383, 1390, 1389.

The line continues west towards Sugnu Village No. 91, Sheet No. 4, covering part of C.S. Dag No. 3093.

The line again moves west towards Sugnu Village No. 91, Sheet No. 2, covering southern boundaries of C.S. Dag No. 1383, 1372, 1371.

Further, the line moves south towards Sugnu Village No. 91, Sheet No. 3, covering C.S. Dag No. 2076, 2073 meets the Burma-Sugnu Road covering C.S. Dag No. 2072, 2203, 2205, 2147, 2150, 2151, 2152, 2155, 2171, 2159, and goes towards east along the road covering C.S. Dag No. 2655, 2123, 2122, 2119 then turn towards south covering C.S. Dag No. 2459, 2484, 2483, 2482, 2481, 2480, 2479, 2511, 2517, 2640, 2518, 2519, 2520, 2521, 2522, 2523, 2524, 2525, 2526, 2527, 2528, 2529, 2520, 2531, 2532, 2677, 2678, 2679, 2681, 2595 cross the road and goes west covering C.S. Dag No. 2588, 2538, 2543, 2542, 2652, 2440, 2438, 2420, 2406, 2396, 2401, 2400, 2399, 2396. The line then moves towards north along the river covering western boundaries of C.S. Dag No. 2393, 2392, 2391, 2390, 2389, 2319, 2317, 2369, 2302, 2292, 2277, 2276, 2275, 2274, 2273, 2272, 2238, 2026, 2025, 2024, 2023, 2022, 2021, 2002 and turn east of same Dag No. and continues towards south covering C.S. Dag No. 2003, 2020, 2026, 2032. Then continues east covering C.S. Dag No.2236, 2235 and goes north along the road covering C.S. Dag No.2231, 2032, 2039, 2011, 2049, 2059 and cross the road, meets the starting point.

#### **BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED SUGNUMUNICIPAL AREA**

#### WARD NO. 1

Starting from the northeast corner of C.S. Dag No. 2059, adjacent to Burma – Sugnu Road of Sugnu Village No. 91, Sheet No. 3, along the road the ward boundary line goes south covering C.S. Dag No. 2072, 2208 until it meets southeast corner of C.S. Dag No. 2221 and continues west covering C.S. Dag No. 2223, 2688, 2234, 2236 then goes towards north along the river covering C.S. Dag No. 2237, 2026, 2025, 2024, 2023, 2022, 2021, 2002 and turn east of same Dag No. and continues towards south covering C.S. Dag No. 2003, 2020, 2026, 2032. Then continues east covering C.S. Dag No.2236, 2235 and goes north along the road covering C.S. Dag No. 2231, 2032, 2039, 2011, 2049, 2059 and cross the road, meets the starting point.

#### WARD NO. 2

Starting from the northeast corner of C.S. Dag No. 2259 of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes south along the road covering C.S. Dag No. 2259, 2258, 2262, 2264, 2288, 2289, 2293 and moves towards west covering C.S. Dag No. 2292, 2291, 2670, 2280, 2279, 2277, then continues north along the river covering C.S. Dag No. 2277, 2276, 2275, 2274, 2273, 2272, 2238 and moves towards east along the road covering C.S. Dag No. 2239 and meets the starting point.

#### WARD NO. 3

Starting from the northeast corner of C.S. Dag No. 2295 of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes south along the road covering C.S. Dag No. 2296, 2298, 2663, 2342, 2666 and goes west covering C.S. Dag No. 2667, 2339, 2340, 2329, 2325, 2316, parts of 2317, then continues north along the river covering C.S. Dag No. 2317, 2639, 2302 and continues towards east along the road covering C.S. Dag No. 2308, 2307, 2304, 2303, 2302 and meets the starting point.

#### WARD NO. 4

Starting from the northwest corner of C.S. Dag No. 2208 of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes east and goes south covering C.S. Dag No. 2449 and continues west along the road covering C.S. Dag No. 2351, 2333, 2332, 2323, 2653, 2320, 2319 then goes north along the river covering C.S. Dag No.2319, part of 2317 and turn east covering 2322, 2324, 2330, 2336, 2338, 2337, parts of 2666 and meets the starting point.

### WARD NO. 5

Starting from the northeast corner of C.S. Dag No. 2412 of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes south covering C.S. Dag No. 2411, 2409, 2408 and continues west covering southern boundaries of C.S. Dag No. 2396, 2401, 2400, 2399, 2396. The line then moves towards north along the river covering western boundaries of C.S. Dag No. 2393, 2392, 2391, 2390, 2389, part of 2319 and continues east along the road covering C.S. Dag No. 2387, 2380, 2378, 2367, 2365, 2332, cross the road meets the starting point.

# WARD NO. 6

Starting from the northeast corner of C.S. Dag No. 2514 adjacent to Burma – Sugnu Road of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes east along the road covering C.S. Dag No. 1513, 2663 and goes south covering eastern boundaries of C.S. Dag No. 2663, 2517, 2640, 2518, 2519, 2520, 2521, 2522, 2523, 2524, 2525, 2526, 2527, 2528, 2529, 2520, 2531, 2532, 2677, 2678, 2679, 2681, 2595 cross the road and goes west covering C.S. Dag No. 2588, 2538, 2543, 2542, 2652, 2440, 2438, 2420, 2406 then continues north—covering western

boundaries of C.S. Dag No. 2419, 2418, 2417, 2416, 2415, 2414, 2448 and goes east along the road covering C.S. Dag No. 2450, 2451 and cross the road and meets the northwestern corner of C.S. Dag No. 2515 and meeting the starting point.

#### WARD NO. 7

Starting from the northwest corner of C.S. Dag No. 2684 of Sugnu Village No. 91, Sheet No. 3, the ward boundary line goes east along the road covering C.S. Dag No. 2162, 2163, 2159 slightly moves south along the road and continues east covering C.S. Dag No. 2655, 2123, 2122, 2119 then turn towards south covering C.S. Dag No. 2459, 2484, 2483, 2482, 2481, 2480, 2479, 2511 and moves north on same Dag No. and goes west along the road covering C.S. Dag No. 2477, 2476, 2475, 2472, 2471, 2470, 2469, 2462, 2461, 2460, 2459, 2458, 2457, 2643, 2644, 2645, 2646, 2647, 2648, 2649, 2650 until reaches the southwest corner of C.S. Dag No. 2162 then moves towards north covering C.S. Dag No. 2700, 2699, 2698, 2697, 2696, 2695, 2694, 2693, 2692, 2691, 2690, 2689, 2688, 2687, 2686, 2685 meets the starting point.

#### WARD NO. 8

Starting from the northwest corner of C.S. Dag No. 2196 of Sugnu Village No. 91, Sheet No. 3, adjacent to Burma – Sugnu Road, the ward boundary line goes east along the road covering C.S. Dag No. 2198, 2202, 2203, 2205, 2147, 2150, 2151, 2152, 2155, 2171 and goes west covering C.S. Dag No. 2171, 2170, 2164, 2675, 2676 then goes north along the road covering C.S. Dag No. 2165, 2166, 2167, 2168, 2188, 2189, 2191, 2192, 2193, 2194, 2195 meets the starting point.

# WARD NO.9

starting from the northwest corner of C.S. Dag No. 1364, adjacent to the Burma – Sugnu road of Sugnu Village No. 91, Sheet No. 2, the boundary line goes east covering C.S. Dag No. 1364, 1385, 1383, 1390, 1389.

The line continues west towards Sugnu Village No. 91, Sheet No. 4, covering part of C.S. Dag No. 3093.

The line again moves west towards Sugnu Village No. 91, Sheet No. 2, covering southern boundaries of C.S. Dag No. 1383, 1372, 1371.

The line goes towards Sugnu Village No. 91, Sheet No. 3, covering C.S. Dag No. 2076 and moves north toward Sugnu Village No. 91, Sheet No. 2, along the road covering C.S. Dag No. 1371, 1370, 1368, 1367, 1493, 1385, 1491 meets the starting point.
