NOTIFICATION

Imphal, the 3rd November, 2025

No.SCS-401/6/2025-MAHUD-MAHUD/21: Whereas, Town Planning Department, Manipur in collaboration with the Wangjing Lamding Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Wangjing Lamding Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Wangjing Lamding Municipal Council in its meeting held on 13.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Wangjing LamdingMunicipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Thoubal in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED WANGJING LAMDING MUNICIPAL AREA

Starting from the northwest corner of C.S. Dag No. 1657 (Ward No. 4) of Wangjing Village No. 133 Sheet No. 2, the boundary line goes towards east along the canal covering the northern boundaries of C.S. Dag Nos. 1655, 1256, 1255, 1243, 1240, 1203, 1204, 1205, 1200, 1166, 1165, 1164, 1162, 1161, 1081, 1142, 1139, 1133, 1082 and goes south covering the eastern boundaries of C.S. Dag Nos. 1083, 1084, 1657, 1099, 1095, 1096, 1651, 1570, 1472, 1469, 1462, 1451, 1455, 1454, 1453, 1585, 1584, 1591, 1592, 1594, 1603, 1602, 1601, 1600, 1511 .

The line continues south towards Wangjing Village No. 133, covering eastern boundaries of C.S. Dag No. 2286, 2285, 2284, 2279, 2278, 2277, 2270, 2274, 2273, 2272, 2271, 2270, 2268, 2267, 2266 and turn towards west covering the southern boundaries of C.S. Dag No. 2266, 2250, 2198, 2197. The line then goes towards west covering the southern boundaries of C.S. Dag Nos. 2197, 2020 and goes north covering the western boundaries of C.S. Dag Nos. 2020, 2119 again turns towards west covering the southern boundaries of C.S. Dag No. 2127, 2128 and continues north covering western boundaries of C.S. Dag No. 2129, 2064 and turns west covering the southern boundaries of C.S. Dag No. 2131 then turns north covering the western boundaries of C.S. Dag No. 2131, 2061 and meets the south east corner of C.S. Dag No. 2016. The line then turns west covering the southern boundaries of C.S. Dag No. 2016 and turns north covering the western boundaries of C.S. Dag Nos. 2016, 2017 then turns west covering the southern boundaries of C.S. Dag Nos. 2007, 2006 and meets NH 102.

The line then moves towards Lamding Village No. 34, Sheet No. 1, covering southern boundaries of C.S. Dag Nos. 113, 114, 129, 130, 132 and meets the Wangjing river. Then the line continues towards northeast along the river covering the northern boundaries of C.S. Dag Nos. 132, 133 and crosses the river. The line continues towards west covering southern boundaries of C.S. Dag No. 136, 137, 225, 156, 158.

Further, the line continues north, towards the Cherapur Village No. 35, covering western boundaries of C.S. Dag No. 293, 292, 279, 274, 328, 326, 325 and turn towards east along the canal covering C.S. Dag No. 262 and crossing the NH 102, meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED WANGJING LAMDING MUNICIPAL AREA

WARD NO. 1

Starting from the northeast corner of C.S. Dag No. 187 of Lamding Village No. 34, Sheet No. 1, the ward boundary line goes towards south along the NH 102 till it reaches the southeast corner of C.S. Dag No. 113 and turn west covering southern boundaries of C.S. Dag Nos. 113, 114, 129, 130, 132 and meets the Wangjing river. Then the line continues towards northeast along

the river covering the northern boundaries of C.S. Dag Nos. 132, 133, 127, 126, 125, 124, 123, 88, 87, 86, 85, 84, 83, 73 and meets the starting point.

WARD NO. 2

Starting from the northeastern corner of C.S. Dag No. 264 of Cherapur Village No. 35, the ward boundary line goes south along the NH 102, covering C.S. Dag No. 265.

The line continues south towards Lamding Village No. 34, Sheet No. 1, along the NH 102 till it reaches the southeast corner of C.S. Dag No. 71 and continues west along the road covering the southern boundaries of C.S. Dag No. 71, 68, 67, 66 and meets the river. The line then goes south along the river until it reaches southwest corner of C.S. Dag No. 134 and moves northward along the road covering the western boundaries of C.S. Dag Nos. 134, 135, 53, 54, 55, 56, 57, 58, 59, 60, 61 and slightly turns towards west covering southern boundaries of C.S. Dag No. 17, 18 then goes north along the road covering the western boundaries of C.S. Dag Nos. 19, 20, 188, 7

The line then continues north towards Cherapur Village No. 35, covering C.S. Dag Nos. 265, 264 and meeting the starting point.

WARD NO. 3

Starting from southeast corner of C.S. Dag No. 136 of Lamding Village No. 34, Sheet No. 1, the ward boundary line goes towards west covering southern boundaries of C.S. Dag No. 136, 137, 225, 156, 158.

The line then continues north, towards the Cherapur Village No. 35, covering the western boundaries of C.S. Dag Nos. 293, 292, 279, 274, 328, 326, 325 and turn east along the canal covering the northern boundaries of C.S. Dag No. 324, 340, 263 and continues south covering the eastern boundaries of C.S. Dag No. 263, 266.

Further, the line continues south towards Lamding Village No. 34, Sheet No. 1, covering the eastern boundaries of C.S. Dag Nos. 2, 3, 21, 22, 24, 25, 26, 27, 28, 29, 30, 31, 46, 47, 48, 49, 50, 51, 52, 190, 146, 145, 144, 143, 142, 141, 140, 136 and meets the starting point.

WARD NO. 4

Starting from the northwest corner of C.S. Dag No. 1657 of Wangjing Village No. 133, Sheet No. 2, the boundary line goes towards east along the canal covering the northern boundaries of C.S. Dag Nos. 1655, 1256, 1255, 1243, 1242 and turn south along the road covering the eastern boundaries of C.S. Dag Nos. 1245, 1246, 1247, 1248, 125, 1212, 1281, 1280, 1279 and 1278.

The line then continues south towards Wangjing Village No. 133, covering the eastern boundaries of C.S. Dag Nos. 5015, 5016, 5017, 5018, 5027, 5028, 5030, 5037, 5032, 5073, 5072, 5091 and turns west along the river covering the southern boundaries of C.S. Dag Nos. 5090, 5089, 5087, 5132, 5082, 5076 and meets the NH 102 continues north along the road covering the

western boundaries of C.S. Dag Nos. 5071, 5070, 5069, 5068, 5067, 5066, 5065, 5145, 5144, 5143, 5142, 5052, 5051, 5140, 5141, 5050, 5049, 5048, 5047, 5008, 5007, 5006, 5005, 5004, 5161, 5162, 5163, 5164, 5165.

The line again continues north towards Wangjing Village No. 133, covering the western boundaries of C.S. Dag Nos. 1623, 1265, 1264, 1280, 1281, 126, 1259, 1609, 1258, 1681 and meets the starting point.

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 1238 of Wangjing Village No. 133, Sheet No. 2, the ward boundary line goes towards east along the canal covering the northern boundaries C.S. Dag Nos. 1239, 1204, 1205 and turns south along the road covering the eastern boundaries of C.S. Dag No. 1206, 1200, 1208, 1209, 1624, 1212, 1214, 1815, 1217, 1218, 1219, 1220, 1221, 1222, 1223, 1777, 1298, 1293, 1160, 1294, 1295, 1665, 1197, 1198, 1199, 1683, 1684 and meets the northwest corner of C.S. Dag No. 1303 then turns east along the road covering the northern boundaries of C.S. Dag Nos. 1303, 1313, 1330, 1332, 1341 and goes south along the road until it meets the southeast corner of C.S. Dag Nos. 1340. The line continues west along the river covering the southern boundaries of C.S. Dag Nos. 1340, 1339, 1322, 1657, 1320, 1304, 1302 and cross the road until it reaches southwest corner of C.S. Dag No. 1663.

Further, the line continues east towards Wangjing Village No. 133, covering the northern boundaries of C.S. Dag Nos. part of 5027 and turn north along the road covering the western boundaries of C.S. Dag Nos. 5026, 5025, 5024, 5023, 5022, 5021, 5020.

The line again continues north towards Wangjing Village No. 133, Sheet No. 2, along the road covering the western boundaries of C.S. Dag No. 1287, 1286, 1285, 1284, 1225, 1226, 1748, 1228, 1229, 1230, 1234, 1231, 1336, 1235, 1670, 1237 and meets the starting point.

WARD NO. 6

Starting from the northwestern corner of C.S. Dag No. 1200 of Wangjing Village No. 133, Sheet No. 2, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 1166, 1165, 1164, 1162, 1161, 1142, 1139, 1133, 1082, 1080, 1077 and turn south covering the eastern boundaries of C.S. Dag Nos. 1078, 1091, 1092, 1570, 1472, 1469, 1462, 1451, 1455, 1454, 1453. Then the line turns west along the river covering the southern boundaries of C.S. Dag Nos. 1452, 1706, 1715, 1411, 1418, 621, 1426, 1428, 1349 and goes towards north along the road covering the western boundaries of C.S. Dag No. 1348, 1346, 1344 and meets the southwestern corner of C.S. Dag No. 1661 then turn west covering the southern boundaries of C.S. Dag Nos. 1150, 1177, 1675, 1178. The line again goes north covering the western boundaries of C.S. Dag Nos. 1178, 1179, 1180, 1181, 1182, 1183, 1184, 1185, 1186, 1187, 1188, 1189, 1190, 1192, 1193, 1194, 1649, 1648, 1195, 1196, 1199, 1198, 1673, 1199 and meets the starting point.

WARD NO. 7

Starting from the northwestern corner of C.S. Dag No. 5102 of Wangjing Village No. 133, Sheet No. 6, the ward boundary line goes towards east along the river covering the northern boundaries of C.S. Dag Nos. 5101, 5151, 5097, 5095.

The line continues east towards Wangjing Village No. 133, Sheet No. 2, along the river covering the northern boundaries of C.S. Dag Nos. 1315, 1359, 1363, 1364, 1365, 1384 and goes south along the road covering the eastern boundaries of C.S. Dag Nos. 1386, 1381, 1380, 1379, 1346, 1375, 1374, then turns west covering southern boundaries of C.S. Dag Nos. 1374, 1735, 1373, 1718, 1717, 1371, 1703, 1702 and cross the road.

Further, the line continues south towards Wangjing Village No. 133, Sheet No. 1, along the road under C.S. Dag No. 2063 till it reaches southeast corner of C.S. Dag No. 2062 and turns west covering the southern boundaries of C.S. Dag No. 2131 then turns north covering the western boundaries of C.S. Dag No. 2131, 2061 and meets the south east corner of C.S. Dag No. 2016. The line then turns west covering the southern boundaries of C.S. Dag No. 2016 and turns north covering the western boundaries of C.S. Dag Nos. 2016, 2017 then turns west covering the southern boundaries of C.S. Dag Nos. 2007, 2006 and meets NH 102 and turn north along the road till it reaches the northwest corner of C.S. Dag No. 2002 then cross the road covering C.S. Dag No. 5013 and meets the starting point.

WARD NO. 8

Starting from the northwest corner of C.S. Dag No. 2093 of Wangjing Village No. 133, the ward boundary line goes towards east along the road covering the northern boundaries of C.S. Dag Nos. 2094, 2096, 2228 and goes towards south along the road covering the eastern boundaries of C.S. Dag Nos. 2225, 2224, 2222, 2218, 2217, 2216, 2215, 2213, 2212, 2211, 2210, 2208, 2207, 2206, 2584, 2202, 2201, 2200, 2198, 2197. The line then goes towards west covering the southern boundaries of C.S. Dag Nos. 2197, 2020 and goes north covering the western boundaries of C.S. Dag Nos. 2020, 2119 again turns towards west covering the southern boundaries of C.S. Dag No. 2127, 2128 and continues north along the road covering western boundaries of C.S. Dag No. 2129, 2064, 2063 and meets the starting point.

WARD NO. 9

Starting from the northeast corner of C.S. Dag No. 1584 of Wangjing Village No. 133, Sheet No. 2, the ward boundary line goes towards south covering the eastern boundaries of C.S. Dag No. 1584, 1591, 1592, 1594, 1603, 1602, 1601, 1600, 1511 of same village.

The line continues south towards Wangjing Village No. 133, covering eastern boundaries of C.S. Dag No. 2286, 2285, 2284, 2279, 2278, 2277, 2270, 2274, 2273, 2272, 2271, 2270, 2268, 2267, 2266 and turn towards west covering the southern boundaries of C.S. Dag No. 2266, 2250 and continues towards north along the road covering the western boundaries of C.S. Dag No. 2249, 2248, 2247, 2246, 2245, 2244, 2243, 2242, 2241, 2240, 2239, 2238, 2465, 2466, 2236, 2235, 2234, 2233, 2492 and cross the road.

Further, the line goes towards Wangjing Village No. 133, Sheet No. 2, covering the southern boundaries of C.S. Dag No. 1396 and turns north along the road covering the western boundaries of C.S. Dag No. 1396, 1395, 1394, 1392, 1391, 1388, 1389 then goes towards east along the river covering the northern boundaries of C.S. Dag No. 1606, 1585 and meets the starting point.
