No.SCS-401/6/2025-MAHUD-MAHUD/23: Whereas, Town Planning Department, Manipur in collaboration with the Yairipok Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Yairipok Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Yairipok Municipal Council in its meeting held on 24.01.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Yairipok Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Thoubal in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED YAIRIPOK MUNICIPAL AREA

Starting from the southwest corner of C.S. Dag No. 607 (Ward No.1) of Village No. 102, Bishnunaha, Sheet No. 1, the boundary line goes north along the road covering C.S. Dag Nos. 833, 349, 662, 992, 991, 990, 989, 347, 346, 345, 344, 342, 341, 340, 582, 581 and turn east along the river till it meets C.S. Dag No. 120 of Kekru Village No. 106. The line again moves towards south covering the eastern boundaries of C.S. Dag Nos. 125, 128, 129, 135, 136, 137, 139, 149, 656 crosses the road, 136, 301 and turns west covering the southern boundaries of C.S. Dag Nos. 301, 300, 298, 289, 290, 283, 284, 277, 276, 270, 271. The line then continues south covering eastern boundaries of C.S. Dag No. 258, 252 and meets the northwest corner of C.S. Dag No. 268 and continues south covering the eastern boundaries of C.S. Dag No. 339, 336, 335, 386 the turns west covering the southern boundaries of C.S. Dag Nos. 388 (Pt), 389 (Pt), 594 (Pt), 393, 396, 397, 410, 413, 228

The line continues west towards Yairipok Bamon Leikai, Village No. 105, Sheet No. 1, covering the southern boundaries of C.S. Dag No. 210, 213, 214, 217, 254, 248, 247 and turn south covering the eastern boundaries of C.S. Dag Nos. 243, 241, 240, 295, 299, 370, 378, 373, 302 and cross the road.

Further, the line continues towards Bishnunaha Village No. 102, Sheet No. 1, covering C.S. Dag Nos. 440, 438, 437, 436, 435, and turns north covering the western boundaries of C.S. Dag No. 434, 249, 238, meets the canal till it reaches the C.S. Dag Nos. 293 and turn south covering the eastern boundaries of C.S. Dag No. 533, 504, 505, 513, 522, 521.

The line again moves south towards Bishnunaha Village No. 102, Sheet No. 2, covering C.S. Dag No. 1075, 1073, 1023, and turn south covering the southern boundaries of C.S. Dag Nos. 1044, 1064, 1658, 1633, 1052 turn towards west covering the southern boundaries of C.S. Dag No. 1052, 1050, 1044, 1043, 1042, 1034, 1033 and turns north covering western boundaries of 1005, crossing the road and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED YAIRIPOK MUNICIPAL AREA

WARD NO. 1

Starting from the southwest corner of C.S. Dag No. 607 of Bishnunaha Village No. 102, Sheet No. 1, the boundary line goes north along the road covering C.S. Dag No. 833, 349, 662, 992, 991, 990, 989, 347, 346, 345, 344, 342, 341, 340, 582, 581 and turn east along the river covering till it reaches the northwest corner of C.S. Dag No. 303 and goes east along the road covering C.S. Dag No. 300 and meets the Wangkhem- Yairipok Road goes south until it meets southwestern corner of C.S. Dag No. 417 and goes east until it meets northeastern corner of C.S. Dag No.293. and turn south covering the eastern boundaries of C.S. Dag No. 533, 504, 505, 513, 522, 521.

The line again moves south towards Bishnunaha Village No. 102, Sheet No. 2, covering C.S. Dag No. 1075, 1073, 1023, and turn south covering the southern boundaries of C.S. Dag Nos. 1044, 1064, 1658, 1633, 1052 turn towards west covering the southern boundaries of C.S. Dag No. 1052, 1050, 1044, 1043, 1042, 1034, 1033 and turns north covering western boundaries of 1005, crossing the road and meets the starting point.

WARD NO. 2

Starting from northeast corner of C.S. Dag No. 63 of Bishnunaha Village No. 102, Sheet No. 1, the ward boundary line goes east along the road covering C.S. Dag No. 63, 64, 65, 952, 951, 98 cross the road towards east covering 508, 203 and meets the canal and goes south till it reaches south east corner of C.S. Dag No. 147 and turn north along the road till it reaches the southeast corner of C.S. Dag No. 301 then turn west along the road till it reaches the southwest corner of C.S. Dag No. 239 then turn north along the river till it meets the starting point.

WARD NO. 3

Starting from the southwest corner of C.S. Dag No. 62 of Bishnunaha Village No. 102, Sheet No. 1, the ward boundary line goes west and north along the river till it reaches the Yairipok Bridge and goes south and meets the Wangkhem- Yairipok Road till it reaches the C.S. Dag No. 93 then turns west along the road till it meets southwest corner of C.S. Dag No. 62 and meets the starting point.

WARD NO. 4

Starting from the southwest corner of C.S. Dag No. 3078 of Bishnunaha Village No. 102, Sheet No. 4, the ward boundary line goes north along the road covering C.S. Dag No. 3080, 3065, 3064, 3052 and cross the road.

The line then moves east towards Yairipok Bamon Leikai Village No. 105, Sheet No. 1, along the road till it reaches C.S. Dag No. 380 turn south along the road covering C.S. Dag No. 388, 389, 165, 377, 391, 392, 384, 375, 167, 168, 187, 189, 191, 192, 193 and cross the road, 243, 241, 240, 295, 299, 378, 373, 302.

Further, the line again moves towards Bishnunaha Village No. 102, Sheet No. 1, covering C.S. Dag No. 440, 438, 437, 436, 435 and turn north covering western boundaries of C.S. Dag No. 434, 249, 238, 204.

The line then continues towards Sheet No. 4 of Bishnunaha Village No. 102, covering the western boundaries of C.S. Dag No. 3101, 3083 and meets the starting point.

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 91 of Yairipok Bamon Leikai, Village No. 105, Sheet No. 1, the ward boundary line goes north along the river till it reaches the northeast corner covering C.S. Dag No. 74 and continues south covering C.S. Dag No. 73, 72, 71, 70, 65, 64, 63 and then turn towards west along the road till it reaches the starting point.

WARD NO. 6

Starting from the southwest corner of C.S. Dag No. 62 of Yairipok Bamon Leikai, Village No. 105, Sheet No. 1, the ward boundary line goes north and meets the river then goes along the river till it reaches northwest corner of Dag No. 34.

The line then moves towards Kekru Village No. 106, alongside the river covering C.S. Dag No. 2, 26, 38 and goes south covering C.S. Dag No. 23, 21, 20, 19, 18, 17, 16, 15, 14, 13, 13 and meets the road and goes west along the road.

Further, the line again moves towards Yairipok Bamon Leikai, Village No. 105, Sheet No. 1 covering C.S. Dag No. 127, 126, 122, 110, 109, 107 and meets the starting point.

WARD NO. 7

Starting from the northwest corner of C.S. Dag No. 396 of Yairipok Bamon Leikai Village No. 105, Sheet No. 1, the ward boundary line goes east along the road covering C.S. Dag No. 263, 144, 143, 142, 131.

The line then moves towards Kekru Village No. 106, covering C.S. Dag No. 664, 205 and goes south covering C.S. Dag No. 205, 206, 207, 208, 209, 210, 227, 228.

Further, the line again moves west towards Yairipok Bamon Leikai, Village No. 105, Sheet No.1, covering C.S. Dag No. 210, 213, 214, 217, 254, 248, 247 then turn north covering C.S. Dag No. 153, 156, 157, 158, 159, 379, 160, 161, 164 and meets the starting point.

WARD NO. 8

Starting from the northwest corner of C.S. Dag No. 32 of Kekru, Village No. 106, the ward boundary line goes east alongside river till it reaches the northwest corner of covering C.S. Dag No. 77 and turn east covering northern boundaries of C.S. Dag No. 77, 76 and goes south covering C.S. Dag No. 74, 68, 65, 64, 52, 51, 671, 672, 177, 178, 179, 180, 181, 255, 258, 252 then turn east covering the northern boundaries of C.S. Dag No. 268, 266 then turn south crosses the road covering the eastern boundaries of C.S. Dag No. 332, 339, 336, 335, 386. The line then turns west covering the southern boundaries of C.S. Dag No. 388(pt), 389 (Pt), 594 (Pt), 393, 396, 397, 410, 413 goes along the canal till it reaches the southwest corner of C.S. Dag No. 230 then turn towards north covering the western boundaries of C.S. Dag No. 229, 226 (Pt), 197, 198, 203, 202, 40, 39, 37, 663, 36, 35, 33

WARD NO. 9

Starting from the southwest corner of C.S. Dag No. 73 of Kekru Village No. 106, the ward boundary line goes north covering C.S. Dag No. 72, 70, 69, 92, 80, 79, 78 and goes east along the river covering C.S. Dag No. 81, 82, 119, 120 and turn south covering boundaries of C.S. Dag No. 125, 128, 129, 135, 136, 137, 139, 149, 656, 163, 301, and goes west covering C.S. Dag No. 301, 300, 298, 289, 290, 283, 284, 277, 276, 270, 271 then the line continues towards north covering C.S. Dag No. 272, 174, 173, 172, 171 and cross the road and meets the starting point.
