No.SCS-401/6/2025-MAHUD-MAHUD/9: Whereas, Town Planning Department, Manipur in collaboration with the Lilong (Imphal West) Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Lilong (Imphal West) Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Lilong (Imphal West) Municipal Council in its meeting held on 19.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Lilong (Imphal West) Municipal Council area including ward boundary.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED LILONG IMPHAL-WEST MUNICIPAL AREA

Starting from northeast corner of C.S. Dag No. 505, adjacent to N.H. 102 (Ward No. 8) of Village No. 67, Langthabal Kunja, Sheet No. 1, the boundary line goes south along the N.H. 102 covering C.S. The line then goes north towards Village No. 67, Langthabal Kunja, Sheet No. 2, covering C.S. Dag No. 1255, 1256, 1257, 1259, 1323, 1325, 1335, 1336, 1339, 1340, 1338, 1346, 1360, 1364, 1387, 1386, 1413, 1412, 1411, 1410 and 1409.

The line continues north towards Village No. 67, Langthabal Kunja, Sheet No. 1, covering C.S. Dag No. 363, 362, 361, 307, 306, 305, 277, 278, 279, 229, 230, 193, 194, 195, 140, 125, 122, 123, 124, 98, 91, and goes east along the road covering C.S. Dag No. 85, 452, 519, 510, 509, 508, 507, 506 and meets the starting point.

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED LILONG IMPHAL-WEST MUNICIPAL AREA

WARD NO. 1

Dag No. 853 and western boundaries of C.S. Dag No. 910, 852, 809, 851, 848, 840, 839, 837, then continues north covering C.S. Dag No. 837, 836, 835, 8354, 833, 805, 809, 810, 733, 675, 674, 680, 681, 682, 683, 684, 685, 686, 687, 688, 689, 690, 691, 652, 649, 648, 641, 640, 639 and continues east covering northern boundaries of C.S. Dag No. 639, 701, 702 and meet road of C.S. Dag No. 1022, 1020 and meets the starting point.

WARD NO. 4

WARD NO. 7

Staring from the southwest corner of C.S. Dag No. 483 of Village No. 73, Narankonjin, Sheet No. 1, the ward boundary line goes north covering western boundaries of C.S. Dag No. 483, 482, 481, 480, 479, 477, 476, 475, 403, 412, 416, 417, 419, 430, 432, 434, 435, 446, 447, 453, 455, 456, 457 and goes south covering C.S. Dag No. 458, 459, 460, 461, 464, 465, 471, 472, 516, 519, 520, 523, 522.

The line then goes north towards Village No. 67, Langthabal Kunja, Sheet No. 2, covering C.S. Dag No. 720, 1256, 1257, 1258 and goes west along the road of C.S. Dag No. 119 and meets the starting point.

WARD NO. 8

Starting from northeast corner of C.S. Dag No. 505, adjacent to N.H. 102 of Village No. 67, Langthabal Kunja, Sheet No. 1, the ward boundary line goes south along the N.H. 102 covering C.S. Dag No. 505, 515, 529, 541, 543, 547, 546, 545, 565, 567, 568, 579, 580, 582, 583, 595, 596, 598 and continues towards west covering C.S. Dag No. 598.

WARD NO. 9
