No.SCS-401/6/2025-MAHUD-MAHUD/1: Whereas, Town Planning Department, Manipur in collaboration with the Andro Municipal Council conducted a household survey to assess the status of water connection under AMRUT 2.0 in Andro Municipal Council areas and whereas it has come to notice that there are many voters whose residential units are located beyond the municipal limits and the boundary delineated by the official gazette do not conform to the existing ward boundaries.

Whereas, the Andro Municipal Council in its meeting held on 19.03.2025 resolved to submit a proposed boundary to the government for approval and whereas, the state government after careful examination considered to issue a notification under Section 3(3) of the Manipur Municipalities Act, 1994 indicating the local limits of the area to be included within the Municipality.

Now, therefore, in exercise of the power conferred under Section 3 (1) read with Section 3 (2), (3) and (4) of the Manipur Municipalities Act, 1994, the Governor of Manipur is pleased to publish the draft running boundary descriptions of the Andro Municipal Council area including ward boundary.

Any resident of the local area in respect of which the draft has been published may submit objections if any to the Deputy Commissioner, Imphal East in writing within 45 days from the date of publication of this Notification.

RUNNING BOUNDARY DESCRIPTION OF THE PROPOSED ANDRO MUNICIPAL AREA

(PART - I)

Starting from the northwest corner of C.S. Dag No. 1048 of Nungkot Village No. 85, Sheet No.2 (Ward No.1) adjacent to Napet Palli-Andro Road, the boundary line goes east covering eastern boundaries of C.S. Dag Nos. 1048, 1049 by touching the northern boundary of C.S. Dag No. 1048 and meet the northeastern corner of C.S. Dag No. 43 of Andro Village No. 86 (Sheet No.1).

The line then continues south towards Andro Village No. 86 (Sheet No.1), covering eastern boundaries of C.S. Dag Nos. 43, 45, 40, 33, 116, 118, 125, 119 by touching the southern boundaries of C.S. Dag No. 40, 41, 118, 119 and meet the Napet Palli-Andro Road, then the line goes south till it meets the north-east corner of C.S. Dag No. 1137 of Andro Village No. 86 (Sheet No.2).

Further, the line continues south of Andro Village No. 86 (Sheet No.2) covering the eastern boundaries of C.S. Dag Nos. 1137, 1136, 1184, 1193, 1196,1187, 1191 by touching the southern and western boundary of C.S. Dag No. 1196, 1193. Then the line slightly turns toward west covering the southern boundaries of C.S. Dag nos. 1187, 1186, 1185 till it touches the north-eastern corner of C.S. Dag No. 1200 then the line continues south by covering the eastern boundaries of C.S. Dag No. 1207,1208. Then, the boundary line turns east after meeting the C.S. Dag No. 1209 till it reaches the south-west corner of C.S. Dag No. 1204. The boundary line continues north-east in a zig zag pattern from the south-west corner C.S. Dag No. 1204 by covering the northern boundaries of C.S. Dag Nos. 1204, 1203, 1202 by touching the western boundaries of C.S. Dag Nos. 1204, 1202. The boundary line then crosses the Napet-Palli Andro Road and touches the north-west corner of C.S. Dag No. 1541, then the line continues east along the northern boundary of the same Dag i.e. C.S. Dag No. 1541 and turn south when the line reaches the north-east corner of the Dag i.e. C.S. Dag No. 1541. Further the boundary line continues south by covering eastern boundaries of C.S. Dag Nos. 1541, 1540, 1536, 1533 by touching the northern boundary of C.S. Dag No. 1533 then the line again meets C.S. Dag No. 1529 and continues east till reaches the south-west corner of C.S. Dag No. 1533. Then, the line further continues north-east by covering the northern boundaries of C.S. Dag No. 1533 and south-west part of 1530, 1554 by touching the western boundary of C.S. Dag No. 1533. From the south-west corner of C.S. Dag No. 1554 the boundary line continues south along the canal till it touches the north-east corner of C.S. Dag No. 2172 of Andro Village No. 86 (Sheet No.2).

From the north-west corner of C.S. Dag No. 2172 of Andro Village No. 86 (Sheet No.2), the boundary line continues south along the canal till it touches the north-west corner of C.S. Dag No. 2116, covering some portion of the south-west corner part of the Dag, then the line further continues along the canal till it again meet the north-west corner of C.S. Dag No. 2151 (covering the north-west corner part of the Dag) and follow the canal till it touches the south-east corner of C.S. Dag No. 2153. The boundary line continues west covering the southern boundary of C.S. Dag No. 2153 and meets the Napet Palli-Andro Road, then the boundary line slightly turns north and continues west after touching the south-east corner of C.S. Dag No. 2027 by covering the southern boundaries of C.S. Dag No. 2027, 2026, 2484,2034, 2022, 2020 and also by touching the western boundary of C.S. Dag No. 2026, 2025 and eastern boundary of C.S. Dag No. 2023,2022.

From the south-west corner of C.S. Dag No. 5030 of Andro Village No. 86 (Sheet No.6), continues west by covering the southern boundaries of C.S. Dag No. 5033, 5032, 5034, 5031, 5030 then the boundary line turns north and meet the north-west corner of the same Dag and then continues east by covering the northern boundaries of C.S. Dag No. 5030, 5031, 5032, 5033 and touch the south-west corner of C.S. Dag No. 2001 of Andro Village No. 86 (Sheet No.3).

Further, the boundary line continues north from the south-west corner of C.S. Dag No. 2001 of Andro Village No. 86 (Sheet No.3) by covering the western boundaries of C.S. Dag No. 2001 and meet the C.S. Dag No. 6139 of Andro Village No. 86 (Sheet No.7).

Further, the boundary line continues north from the C.S. Dag No. 6139 of Andro Village No. 86 (Sheet No.7) till it meets the north-west corner of C.S. Dag No. 6150. The boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 6150, 6152 and turn slightly south by covering the eastern boundaries of 6152, 6153. From the south-east corner of C.S. Dag No. 6153 the boundary line continues straight to touch the north-west corner of C.S. Dag No. 6109 and continue along the same Dag by covering its northern boundary and meet the north-west corner of C.S. Dag No. 6110. The Boundary line further continues north by covering the western boundaries of C.S. Dag No. 6123, 6125 and the line turn east by covering the northern boundaries of C.S. Dag No. 6125, 6127, 6128, 6133 by touching the western boundary of C.S. Dag No. 6133 and then the line continues east by covering the northern boundaries of C.S. Dag Nos. 6133,6132. The line continues towards south by covering the eastern boundaries of C.S. Dag Nos. 6132, 6131, 6130, 6120 and then the line turns east by covering the northern boundaries of C.S. Dag Nos. 6119, 6118, 6098, 6095, 6094, 6083, 6170, 6168, 6081, 6080 by touching the eastern boundaries of C.S. Dag Nos. 6118, 6099, 6168 and western boundary of C.S. Dag Nos. 6083. The line then continues south covering the eastern boundaries of C.S. Dag Nos. 6080 and meet C.S. Dag Nos. 1240 of Andro Village Nos. 86 (Sheet Nos.2).

The line then continues south from C.S. Dag No. 1240 of Andro Village No. 86 (Sheet No.2) by covering the eastern boundaries of C.S. Dag Nos.1236,1237, 1244 by touching the western boundaries of C.S. Dag No. 1238,1236. The boundary line further continues east passing some portion of C.S. Dag no. 1263 and touches the north-west corner of C.S. Dag No. 1232 and then the line slightly turn north and continues east by covering the northern boundaries of C.S. Dag Nos. 1233, 1211 and meets the C.S. Dag No. 1209.

The boundary line further continues north-west along the C.S. Dag Nos. 6076 of Andro Village No. 86 (Sheet No.), till it meets the south-west corner of C.S. Dag No. 6075. Then the boundary line turns north by covering the western boundaries of C.S. Dag Nos. 6075,6008, 6007, 6006, 6005 by touching the southern and northern boundary of C.S. Dag 6007 and 6006 respectively. Then the boundary line slightly turns east by covering the northern boundaries of C.S. Dag Nos. 6001, 6002 and slightly bend towards south by covering the eastern boundaries of C.S. Dag Nos. 6014, 6015, 6016. Further the boundary line changes its direction to east by covering the northern boundaries of C.S. Dag Nos. 6017, 6025, 6026, 6027, 6028, 6031, 6032, 6033, 1018 by touching the western and eastern boundaries of C.S. Dag. No. 6030 and 6032 respectively and meets the south-west corner of C.S. Dag No. 1009 of Andro Village No. 86 (Sheet No.2).

From the south-west corner of C.S. Dag No. 1009 of Andro Village No. 86 (Sheet No.2), the boundary line continues toward north-west, then slightly turn north-east and continues south by covering the whole C.S. Dag Nos. 1003, 1002,1001 till it meets the north-west corner of C.S. Dag No. 1009. The boundary line further continues north-east by covering the western boundaries of C.S. Dag

Nos. 1009, 1066, 1012 and then the line continues north-east by covering the northern boundaries of C.S. Dag Nos. 1012, 1015. The boundary line turns southward by covering the eastern boundaries of C.S. Dag No. 1015, 1602 and then the line turns south-west direction by covering the southern boundaries of C.S. Dag Nos. 1602, part of 1066, 1616, 1009. Further, the lines shift its direction to south-east by covering the eastern boundaries of C.S. Dag Nos. 1018, part of 1017, 1047 till it meets the north-west corner of C.S. Dag No. 1070. From the north-west corner of C.S. Dag No. 1070 the boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 107 0, 1071, 1072, 1073 and meet the south-west corner of C.S. Dag No. 26 of Andro Village No. 86 (Sheet No.1).

From the south-west corner of C.S. Dag No. 26 of Andro Village No. 86 (Sheet No.1), the boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 25, 22, 18, 17, 15, 11, 2, 1 by touching the western boundaries of C.S. Dag Nos. 19, 18 then it meets the north-west corner of C.S. Dag No. 1043 of Nungkot Village No. 85.

Then the line continues towards south of Nungkot Village No. 85 (Sheet No.2) covering the eastern boundaries of C.S. Dag Nos. 1043, 1127 till it meet and crosses the Napet Palli-Andro Road and meets the starting point i.e. the northwest corner of C.S. Dag No. 1048 of Nungkot Village No. 85

(PART - II)

Starting from the north-west corner of C.S. Dag No. 3140 of Andro Village No. 86 (Sheet No.4), adjacent to road running eastward direction from ward no. 6, the boundary line goes south along the foothill till it meets the south west corner of C.S. Dag No. 3238 by touching the eastern and northern boundary of C.S. Dag No. 3140. Then the boundary line continues north by covering the western boundaries of C.S. Dag Nos. 3239, 3245, 3207, 3177, 3169, 3141 and meet the starting point i.e. the north-west corner of C.S. Dag No. 3140 of Andro Village No. 86.

(PART - III)

Starting from the north-west corner of C.S. Dag No. 2239 of Andro Village No. 86 (Sheet No. 3), adjacent to Napet Palli- Andro Road, the boundary line goes south by covering the eastern boundaries of C.S. Dag No. 2239, 2318, 2317, 2366, 2367 by touching the northern and southern boundary of C.S. Dag No. 2239 and 2317 respectively. Then the boundary line meets and crosses the Napet Palli Andro Road and the line continues north-west by covering the western boundaries of C.S. Dag Nos. 2364, 2363, 2362, 2361, 2358, 2357, 2354, 2353 by touching the southern boundaries of C.S. Dag Nos. 2365, 2364. The boundary line then turns north by covering the western boundaries of C.S. Dag Nos. 2352, 2351, 2350, 2346, 2345, 2344, 2343, 2333, 2332, 2329, 2328, 2228, 2227, 2225, then the boundary line continues east along the C.S. Dag No. 2224 by covering the whole C.S. Dag no. 2180 and still continues in east direction by covering the northern boundaries of C.S. Dag Nos. 2218, 2219, 2213, 2212, 2210. The boundary line continues south-east by covering the eastern boundaries of C.S. Dag Nos. 2210, 2155 then meets the Napet Palli-Andro Road and then the boundary line turns south along the road and meet the starting point i.e. the north-west corner of C.S. Dag No. 2239 of Andro Village No. 86(Sheet No. 3)

BOUNDARY DESCRIPTION (WARDWISE) OF THE PROPOSED ANDRO MUNICIPAL AREA

WARD NO. 1

Starting from the northwest corner of C.S. Dag No. 1048 of Nungkot Village No. 85 (Sheet No.2) adjacent to Napet Palli-Andro Road, the ward boundary line goes east covering eastern boundaries of C.S. Dag Nos. 1048, 1049 by touching the northern boundary of C.S. Dag No. 1048 and meet the north-eastern corner of C.S. Dag No. 43 of Andro Village No. 86 (Sheet No.1).

The line then continues south towards Andro Village No. 86(Sheet No.1), covering eastern boundaries of C.S. Dag Nos. 43, 45, 40, 33, 116, 118, 125, 119 by touching the southern boundaries of C.S. Dag No. 40, 41, 119, 118 and meet the Napet Palli-Andro Road. The ward boundary line goes south till it meets the north-east corner of C.S. Dag No. 1137 Andro Village No. 86 (Sheet No.2).

From the north-east corner of C.S. Dag No. 1137 Andro Village No. 86 (Sheet No.2), the line continues north-west by covering the western boundaries of C.S. Dag Nos. 1139, 1140, 1143, parts of 1142, parts of 1018 till it meets the north-west corner of C.S. Dag No. 1019 by touching the part of eastern and western boundary of C.S. Dag Nos. 1137. The boundary line then continues north-east by covering the northern boundaries of C.S. Dag Nos. 1019, 1020, 1042, 1046 by touching the western boundary of C.S. Dag No. 1045. Further, the lines shift its direction to south-east by covering the eastern boundaries of C.S. Dag Nos.1017 (part of), 1047 till it meets the north-west corner of C.S. Dag No. 1070. From the north-west corner of C.S. Dag Nos. 1070 the boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 1070, 1071, 1072, 1073 and meet the south-west corner of C.S. Dag No. 26 of Andro Village No. 86 (Sheet No.1).

From the south-west corner of C.S. Dag No. 26 of Andro Village No. 86 (Sheet No.1), the ward boundary continues east by covering the northern boundaries of C.S. Dag Nos. 25, 22, 18, 17, 15, 11, 2, 1 by touching the western boundaries of C.S. Dag Nos. 19, 18 then it meets the north-west corner of C.S. Dag No. 1043 of Nungkot Village No. 85.

Then the line continues towards south of Nungkot Village No. 85 (Sheet No.2) covering the eastern boundaries of C.S. Dag Nos. 1043, 1127 till it meet and crosses the Napet Palli-Andro Road and meets the starting point i.e. the northwest corner of C.S. Dag No. 1048 of Nungkot Village No. 85.

WARD NO. 2

Starting from the southeast corner of C.S. Dag No. 1138 of Andro Village No. 86(Sheet No.3), adjacent to the Napet Palli-Andro, the ward boundary line goes south covering the eastern boundaries C.S. Dag No. 1138 and part of 1137. Then the line continues west covering the southern boundaries of the line continues south covering the eastern boundaries of C.S. Dag Nos. 1136, 1184, 1193, 1196,1187, 1191 by touching the southern and western boundary of C.S. Dag No. 1196, 1193 respectively. Then the line slightly turns toward west covering the southern boundaries of C.S. Dag nos. 1187, 1186, 1185 till it touches the north-eastern corner of C.S. Dag No. 1200 then the line continues south by covering the eastern boundaries of C.S. Dag No. 1207,1208 till it meets the northeast corner of C.S. Dag No. 1210. Then the ward boundary line turns north-west along C.S. Dag No. 1209 and continues north-west along C.S. Dag Nos. 6076 of Andro Village No. 86 (Sheet No.7) and turns north-east till it meets the south-west corner of C.S. Dag No. 6056. Then the boundary line turns north-east by covering the western boundaries of C.S. Dag Nos. 1178, eastern part of 1018 split up by road, 1175,1142 till it touches the north west corner of C.S. Dag No. 1018. Then the boundary line changes its direction to east by covering the northern boundaries of C.S. Dag Nos. 1018 and meets the

south-west corner of C.S. Dag No. 1009. From the south-west corner of C.S. Dag No. 1009 the boundary line continues toward north-west, then slightly turn north-east and continues south by covering the whole C.S. Dag Nos. 1003, 1002,1001 till it meets the north-west corner of C.S. Dag No. 1009. The boundary line further continues north-east by covering the western boundaries of C.S. Dag Nos. 1009, 1066, 1012 and then the line continues north-east by covering the northern boundaries of C.S. Dag Nos. 1012, 1015. The boundary line turns southward by covering the eastern boundaries of C.S. Dag No. 1015, 1602 and then the line turns south-west direction by covering the southern boundaries of C.S. Dag Nos. 1602, part of 1066, 1616, 1009. Further, the lines shift its direction to south-east by covering the eastern boundaries of C.S. Dag Nos. 1018 till it meets the north-west corner of C.S. Dag No. 1046. The ward boundary line continues south-west along the southern boundary of C.S. Dag No. 1018 and change its direction slightly to north along the foothill and follow the ward boundary of ward no. 1 till it meets the south-west corner of C.S. Dag No. 1143. The ward boundary line further continues south-east along the southern boundary of C.S. Dag No. 1143 and northern boundary of C.S. Dag No. 1138 and meet the starting point i.e. the southeast corner of C.S. Dag No. 1138.

WARD NO. 3

Starting from the northwest corner of C.S. Dag No. 6058, of Andro Village No. 86 (Sheet No.7), the ward boundary line goes south along the inert-village road till it the C.S. Dag No. 6076. The ward boundary line then continues north-west along the C.S. Dag Nos. 6076 till it meets the south-west corner of C.S. Dag No. 6075. Then the boundary line turns north by covering the western boundaries of C.S. Dag Nos. 6075,6008, 6007, 6006, 6005 by touching the southern and northern boundary of C.S. Dag 6007 and 6006 respectively. Then the boundary line slightly turns east by covering the northern boundaries of C.S. Dag Nos. 6001, 6002 and slightly bend towards south by covering the eastern boundaries of C.S. Dag Nos. 6014, 6015, 6016. Further the boundary line changes its direction to east by covering the northern boundaries of C.S. Dag Nos. 6017, 6025, 6026, 6027, 6028, 6031, 6032, 6033 by touching the western and eastern boundaries of C.S. Dag. No. 6030 and 6032 respectively. From the south-east corner of C.S. Dag No. 6033 the boundary line turns south passing part of C.S. Dag No. 1018 then slightly turn south-west along the same Dag till it touches the south-west corner of C.S. Dag No. 1178 of Andro Village No. 86 (Sheet No.2), and meets the starting point i.e. the northwest corner of C.S. Dag No. 6058, of Andro Village No. 86 (Sheet No.7).

WARD NO. 4

Starting from the northeast corner of C.S. Dag No. 1211 of Andro Village No. 86 (Sheet No. 2), adjacent to Andro Kangjeibung, the ward boundary line goes south-east along the C.S. Dag No. 1209 till it meets the north-west corner of C.S. Dag No. 1204. The line turns east by covering the eastern boundaries of C.S. Dag Nos. 1204, 1203,1202,1541 by touching the northern boundaries of C.S. Dag Nos. 1204,1202. Then the line continues east along the northern boundary of Dag No. 1541 and turn south when the line reaches the north-east corner of the Dag i.e. C.S. Dag No. 1541. Further the boundary line continues south by covering eastern boundaries of C.S. Dag Nos. 1541, 1540, 1536, 1533 by touching the northern boundary of C.S. Dag No. 1533 then the line continues east till reaches the south-west corner of C.S. Dag No. 1533 and south-west part of 1530, 1554 by touching the western

boundary of C.S. Dag No. 1533. From the south-west corner of C.S. Dag No. 1554 the boundary line continues south along the canal till it touches the south-west corner of C.S. Dag No. 1484. The boundary line turns north along the C.S. Dag No. 1469 till it meets the Napet Palli Andro Road and then the ward boundary line slightly turns north-east and touches the south-west corner of C.S. Dag No. 1225. From the south-west corner of C.S. Dag No. 1225 the ward boundary line further continues north by covering the western boundaries of C.S. Dag No. 1225, 1226, 1227, 1228, 1223, 1230, 1231, 1232 till it meets the north-west corner of C.S. Dag No. 1233, then the ward boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 1233,1211 and meet the starting point i.e. the northeast corner of C.S. Dag No. 1211 of Andro Village No. 86.(Sheet No.2)

WARD NO. 5

Starting from the northwest corner of C.S. Dag No. 6094 of Andro Village No. 86(Sheet No.7), the ward boundary line goes east by covering the northern boundaries of C.S. Dag Nos. 6083, 6170, 6168, 6081, 6080 by touching the eastern boundaries of C.S. Dag No. 6118, 6099, 6168 and western boundary of C.S. Dag No. 6083.

The line then continues south of Andro Village No. 86(Sheet No.2), covering the eastern boundaries of C.S. Dag Nos. 1240, 1236,1237, 1244 by touching the western boundaries of C.S. Dag No. 1238,1236 respectively. The boundary line further continues east passing some portion of C.S. Dag no. 1263 and touches the north-west corner of C.S. Dag No. 1232. Then the boundary line turns south by covering the eastern boundary of C.S. Dag No. 1263 till it meets the Napet Palli-Andro Road and then the ward boundary line continues south-west along the Napet Palli-Andro Road till it touches the south-west corner of C.S. Dag No. 1311. From the south-west corner of C.S. Dag No. 1311 the ward boundary line turns north by covering the western boundaries of C.S. Dag Nos. 1311, 1312, 1313, 1316, 1317, 1320, 1321, 1322, 1323, 1324, 1325, 1326, 1587, 6093, 6094 and meet the starting point i.e. the northwest corner of C.S. Dag No. 6094 of Andro Village No. 86(Sheet No. 7).

WARD NO. 6

Starting from the northwest corner of C.S. Dag No. the northwest corner of C.S. Dag No. 1468 of Andro Village No. 86(Sheet No.2), the ward boundary line goes south along the C.S. Dag No. 1469 till it meets the north-east corner of C.S. Dag No. 1455 and the boundary line turns south-west along the canal till it meets the south-west corner of C.S. Dag No. 2074 of Andro Village No. 86(Sheet No.3).

From the south-west corner of C.S. Dag No. 2074 of Andro Village No. 86(Sheet No.3), the ward boundary line continues toward north-west by covering the western boundaries of C.S. Dag Nos. 2074, 2069.

Then the ward boundary line continues toward north-west of Andro Village No. 86(Sheet No.2), by covering the western boundaries of C.S. Dag Nos. 1585, 1425, 1424, 1423, 1422, 1421, 1420 and meets the Napet Palli-Andro Road. Then the ward boundary line goes north-east along the Napet Palli-Andro Road and meet the starting point i.e. the northwest corner of C.S. Dag No. 1468 of Andro Village No. 86 (Sheet No.2)

WARD NO. 7

Starting from the northeast corner of C.S. Dag No. 6095 of Andro Village No. 86(Sheet No.7), the ward boundary line goes south Andro Village No. 86(Sheet No.2), by covering the eastern boundaries of C.S. Dag No.1327, 1318 till it meets the Napet Palli-Andro Road.

The line then continues south-west along the Napet Palli-Andro Road till it meets the south-east corner of C.S. Dag No. 1402 of Andro Village No. 86(Sheet No.2). From the south-east corner of C.S. Dag No. 1402 the ward boundary line continues north-west by passing the C.S. Dag Nos. 1338, 1363, till it meets the C.S. Dag No. 6019 of Andro Village No. 86(Sheet No.7) by passing C.S. Dag No. 6159.

From the south-east corner of C.S. Dag No. 6109 (of Andro Village No. 86(Sheet No.7), the boundary line continues along the same Dag by covering its northern boundary and meet the north-west corner of C.S. Dag No. 6110. The Boundary line further continues north by covering the western boundaries of C.S. Dag No. 6123, 6125 and the line turn east by covering the northern boundaries of C.S. Dag No. 6125, 6127, 6128, 6133 by touching the western boundary of C.S. Dag No. 6133 and then the line continues east by covering the northern boundaries of C.S. Dag Nos. 6133,6132. The line continues towards south by covering the eastern boundaries of C.S. Dag Nos. 6132, 6131, 6130, 6120 and then the line turns east by covering the northern boundaries of C.S. Dag Nos. 6119, 6118, 6098, 6095 and meets the starting point i.e. the northeast corner of C.S. Dag Nos. 6095 of Andro Village Nos. 86 C.S. Dag Nos. 6109 (of Andro Village Nos. 86 (Sheet Nos.7)).

WARD NO. 8

Starting from the northwest corner of C.S. Dag No. 6152 of Andro Village No. 86(Sheet No.7), the ward boundary line continues south by covering the eastern boundaries of 6152, 6153. From the south-east corner of C.S. Dag No. 6153 the boundary line continues straight to touch the north-west corner of C.S. Dag No. 6109 and then the ward boundary line continues south-east by passing the C.S. Dag No. 6159 till it meets the south-east corner of C.S. Dag No. 1363 of Andro Village No. 86 (Sheet No.2).

Then the ward boundary line continues south-east by passing the C.S. Dag Nos. 1363, 1338 till it meets 1402. From the south-east corner of C.S. Dag No. 1402 the ward boundary line continues south-west by passing the C.S. Dag No. 2014 till it meets the south-east corner of C.S. Dag No. 2008 and meet the north-east corner of C.S. Dag No. 2020 of Andro Village No. 86 (Sheet No.3). Then the boundary line continues east and turn south-west by covering the southern boundaries of C.S. Dag No. 2020, 2001.

The ward boundary turns south-west by covering the southern boundaries of 5033, 5032, 5034, 5031, 5030 of Andro Village No. 86 (Sheet No.6). From the south-west corner of C.S. Dag No. 5030, the boundary line turns north and meet the north-west corner of the same Dag and then continues east by covering the northern boundaries of C.S. Dag No. 5030, 5031, 5032, 5033 and touch the south-west corner of C.S. Dag No. 2001 of Andro Village No. 86 (Sheet No.3).

Further, the boundary line continues north from the south-west corner of C.S. Dag No. 2001 by covering the western boundaries of C.S. Dag No. 2001.

The boundary line further continues north by covering the western boundaries of C.S. Dag Nos. 6139 (part of), 6141 and meets the north-west corner of C.S. Dag No. 6150 of Andro Village No. 86 (Sheet No.7). The boundary line continues east by covering the northern boundaries of C.S. Dag Nos. 6150, 6152 and meet the starting point i.e. the northwest corner of C.S. Dag No. 6152 of Andro Village No. 86 of Andro Village No. 86 (Sheet No.7).

WARD NO. 9

Starting from the north-east corner of C.S. Dag No. 1418 of Andro Village No. 86 (Sheet No.2), adjacent to Napet Palli-Andro Road, the ward boundary line goes east covering the northern boundaries of C.S. Dag Nos. 1419 and meet C.S. Dag No. 2068 of Andro Village No. 86 (Sheet No.3),

Then the line further continues its south-east of Andro Village No. 86 (Sheet No.3), by covering the eastern boundaries of C.S. Dag No. 2075, 2076 till it meets the south-west corner of C.S. Dag No. 2074. From the south-west corner of C.S. Dag No. 2074 the ward boundary line continues south till it meets the south-east corner of C.S. Dag No. 2092. From the south-east corner of C.S. Dag No. 2092 the ward boundary line continues west along the C.S. Dag No. 2093, till it meets the Napet Palli-Andro Road. The ward boundary line further continues north along the Napet Palli-Andro Road till it meets the starting point i.e. the north-east corner of C.S. Dag No. 1418 of Andro Village No. 86 of Andro Village No. 86 (Sheet No.2).

WARD NO. 10

Part - A

Starting from the north-east corner of C.S. Dag No. 2475 of Andro Village No. 86(Sheet No. 3), adjacent to Napet Palli-Andro Road, the ward boundary line goes east along the C.S. Dag No. 2093, till it meets the north-east corner of C.S. Dag No. 2117. From the north-east corner of C.S. Dag No. 2117 the ward boundary line continues south till it meets the south-east corner of C.S. Dag No. 2132 by touching part of C.S. Dag No. 2116. Further, from the south-east corner of C.S. Dag No. 2132 the ward boundary line continues along the southern boundary of C.S. Dag No. 2132 till it meets the Napet Palli-Andro Road. Then, the ward boundary line continues north along the Napet Palli-Andro Road till it meets the starting point i.e. the north-east corner of C.S. Dag No. 2475 of Andro Village No. 86.

Part - B

Starting from the north-west corner of C.S. Dag No. 3140 of Andro Village No. 86 (Sheet No.4), adjacent to road running eastward direction from ward no. 6, the boundary line goes south along the foothill till it meets the south west corner of C.S. Dag No. 3238 by touching the eastern and northern boundary of C.S. Dag No. 3140. Then the boundary line continues north by covering the western boundaries of C.S. Dag Nos. 3239, 3245, 3207, 3177, 3169, 3141 and meet the starting point i.e. the north-west corner of C.S. Dag No. 3140 of Andro Village No. 86 (Sheet No.4).

WARD NO. 11

Starting from the south-east corner of C.S. Dag No. 2027 of Andro Village No. 86, adjacent to Napet Palli-Andro Road, the ward boundary line goes east by touching the southern boundary of C.S. Dag No. 2132 of ward no. 10 (part-A) and then turns south after touching the south-east corner of C.S. Dag No. 2132 by covering some north-west corner part of C.S. Dag No. 2151 and further continues south till it meets the south-east corner of C.S. Dag No. 2153. The boundary line continues west covering the southern boundary of C.S. Dag No. 2153 and meets the Napet Palli-Andro Road, then the

boundary line slightly turns north and continues west after touching the south-east corner of C.S. Dag No. 2027 by covering the southern boundaries of C.S. Dag No. 2027, 2026, 2484,2034, 2022 by touching the western boundary of C.S. Dag No. 2026, 2025 and eastern boundary of C.S. Dag No. 2023,2022. Then, the ward boundary line continues north-east from the south-west corner of C.S. Dag No. 2022 by covering the northern boundaries of C.S. Dag No. 2022, 2023 and slightly turn north from the north-east corner of C.S. Dag No. 2023 till it meets the road. Further, the ward boundary line continues north-east by covering the northern boundary of C.S. Dag No. 2018, 2046, 2047 by passing part of 2014 till it meets the Napet Palli-Andro Road. Then the ward boundary turns south and continues along the Napet Palli-Andro Road till it meets the starting point i.e. the south-east corner of C.S. Dag No. 2027 of Andro Village No. 86.

WARD NO. 12

Starting from the north-west corner of C.S. Dag No. 2239 of Andro Village No. 86 (Sheet No. 3), adjacent to Napet Palli- Andro Road, the boundary line goes south by covering the eastern boundaries of C.S. Dag No. 2239, 2318, 2317, 2366, 2367 by touching the northern and southern boundary of C.S. Dag No. 2239 and 2317 respectively. Then the boundary line meets and crosses the Napet Palli Andro Road and the line continues north-west by covering the western boundaries of C.S. Dag Nos. 2364, 2363, 2362, 2361, 2358, 2357, 2354, 2353 by touching the southern boundaries of C.S. Dag Nos. 2365, 2364. The boundary line then turns north by covering the western boundaries of C.S. Dag Nos. 2352, 2351, 2350, 2346, 2345, 2344, 2343, 2333, 2332, 2329, 2328, 2228, 2227, 2225, then the boundary line continues east along the C.S. Dag No. 2224 by covering the whole C.S. Dag no. 2180 and still continues in east direction by covering the northern boundaries of C.S. Dag Nos. 2218, 2219, 2213, 2212, 2210. The boundary line continues south-east by covering the eastern boundaries of C.S. Dag Nos. 2210, 2155 then meets the Napet Palli-Andro Road and then the boundary line turns south along the road and meet the starting point i.e. the north-west corner of C.S. Dag No. 2239 of Andro Village No. 86(Sheet No. 3).
